AN ORDINANCE 2015 - 09 - 03 - 0738

AUTHORIZING THE ACCEPTANCE OF A LATINO AMERICANS: 500 YEARS OF HISTORY GRANT, PRODUCED BY THE NATIONAL ENDOWMENT FOR THE HUMANITIES (NEH) AND THE AMERICAN LIBRARY ASSOCIATION (ALA) IN THE AMOUNT OF \$3,000.00 IN SUPPORT OF THE SAN ANTONIO PUBLIC LIBRARY'S PROGRAMMING INITIATIVES.

WHEREAS, the San Antonio Public Library plans to implement several programs to highlight and inform the community about Latino American's impact on the USA in the last 500 years; and

WHEREAS, program efforts will take place during Hispanic Heritage Month (September 15, 2015 - October 15, 2015) and March through April of 2016 to include a Cesar Chavez Celebration; and

WHEREAS, the purpose of these programs is to increase the community's access to information about Latino American history in San Antonio and the rest of the country through screenings, panel discussions, exhibits and other programming; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the San Antonio Public Library or his designee is authorized to accept grant funds in the amount of \$3,000.00 from the National Endowment for the Humanities (NEH) and the American Library Association (ALA) to expand its programs and public awareness for Hispanic Heritage Month and a Cesar Chavez Celebration at the San Antonio Public Library for the period September 1, 2015 to June 30, 2016. A copy of the grant application is on file with the San Antonio Public Library.

SECTION 2. The City Manager or her designee, or the Director of the San Antonio Public Library or his designee is further authorized to execute any and all necessary documents to effectuate said grant acceptance.

SECTION 3. Should funding be awarded, Fund 2601804022 and internal order 104000000068 are hereby designated for use in the accounting for the fiscal transaction of this grant and the sum of \$3,000.00 from the NEH and ALA will be appropriated in said fund. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
