

AN ORDINANCE 2015-09-03-0747

**AUTHORIZING THE STREET NAME CHANGE OF “OLD HWY 90” TO “ENRIQUE M BARRERA PKWY” BETWEEN THE CROSS STREETS OF U.S. HWY 90 AND COMMERCE STREET, AND CREATING A MEMORIAL DESIGNATION OF “HISTORIC OLD HWY 90” IN CITY COUNCIL DISTRICT 6, SAN ANTONIO, TEXAS.**

**WHEREAS**, the Development Services Department received a City Council Request from Councilman Ray Lopez (District 6) on July 18, 2014 to rename a section of Old Hwy 90 between U.S. Hwy 90 and Commerce Street as “Enrique M Barrera Pkwy” to recognize and honor Enrique M. Barrera for his service on the Edgewood School Board as Trustee for 12 years and City Council for 5 years; and

**WHEREAS**, staff began implementing this request through the street renaming process as required by Chapter 6 of the City Code; and

**WHEREAS**, several public meetings were held during the street renaming process, public sentiment regarding the loss of the name “Old Hwy 90” and needed street repair work, resulting in the Council Office request to include an “Historic Old Hwy 90” memorial designation on the signs and needed street repair work; and

**WHEREAS**, staff forwarded the request to all City of San Antonio departments and outside agencies for review and acquiescence and no opposition has been identified; and

**WHEREAS**, staff conducted a technical review finding it to conform to City Code requirements for street renaming; and

**WHEREAS**, staff properly posted and mailed notice of this request to attach the street renaming and memorial designation to said street to abutting property owners, notice requirements for renaming of the street and giving the memorial designation of the street have been satisfied in accordance with Chapter 6 of the City Code with seven (7) written oppositions received to the name change from abutting property owners; and

**WHEREAS**, the Planning Commission held a public hearing on January 14, 2015 allowing all interested persons to be heard; and

**WHEREAS**, the Planning Commission, being apprised of the public sentiment concerning the loss of “Old Hwy 90” name and street repair issues, discussed and recommended approval with the condition that the City Council District 6 Office continue to meet with the residents in order to reach a compromise regarding the impact of renaming the street and look at improvements to the street. **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** "Old Hwy 90" located in City Council District 6 between U.S. Hwy 90 and Commerce Street is hereby renamed "Enrique M Barrera Pkwy" and is given the memorial designation of "Historic Old Hwy 90." All naming requirements of Chapter 6 of the City Code have been met, or are hereby waived. The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect and to work with Texas Department of Transportation on the replacement of signs located on U.S. Highway 90 and S.H. 151 in state right of way.

**SECTION 2.** Funds generated by this ordinance will be deposited as per the table below:

**SECTION 3.** Funding in the amount of \$10,000.00 for this Ordinance is available for Fund 29097000, Cost Center 2901061001 and General Ledger 5202020, as part of the Fiscal Year 2015 Budget.

**SECTION 4.** If approved by City Council, a payment not to exceed the budgeted amount of \$10,000.00 is authorized to the Texas Department of Transportation and should be encumbered with a purchase order and through the execution of an Advanced Funding Agreement.


**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.

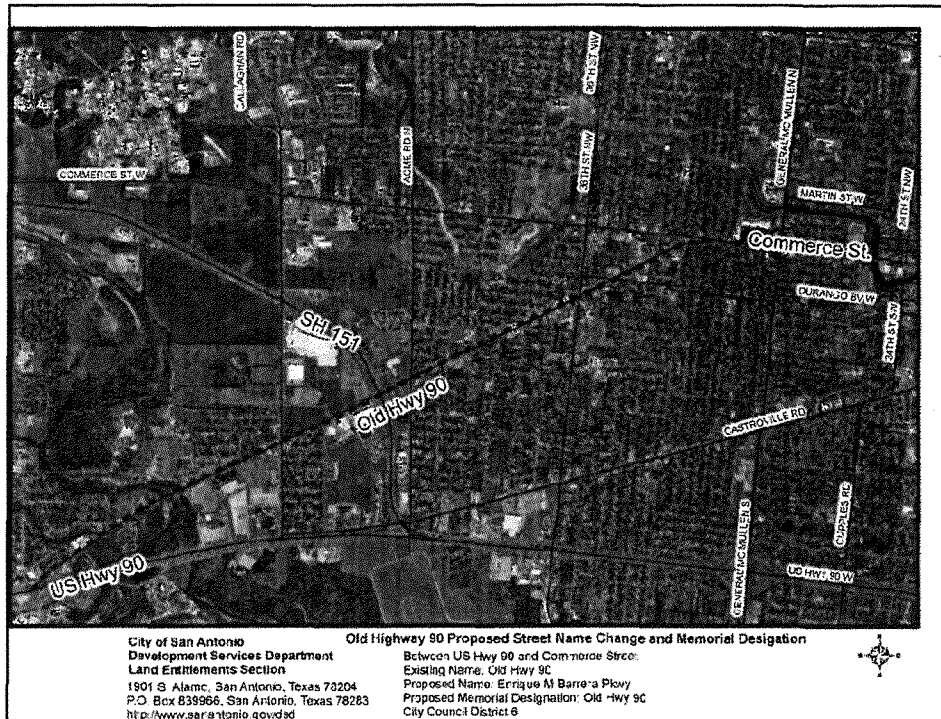
