**EXHIBIT A
SCOPE OF PROJECT**

This Agreement will become binding on the date of the signature by both parties. Notwithstanding this date, the term of this Agreement shall be for the period October 1, 2014 through September 30, 2015, and shall be considered an integral part of the complete contract for Direct Purchases of Services (DPS) between the Alamo Area Council of Governments hereinafter referred to as **AGENCY** and **COSA, Department of Human Services** hereinafter referred to as **CONTRACTOR**. The DPS is a procurement method that provides flexibility and effective management of resources by purchasing services on a client-by-client basis as determined by an assessment, if applicable, of the individual's service needs. The **AGENCY** and the **CONTRACTOR** mutually agree that the **CONTRACTOR** will provide, as a DPS, **Congregate Meals** services for persons in the Bexar County Area Agency on Aging planning and service area and will provide a minimum of **368,390 units** of service at the rate of **\$6.16 per unit**.

The total amount of Title III Federal funds shall not exceed **\$1,469,723**.

The total amount of Nutrition Services Incentive Services (NSIP) funds shall not exceed **\$630,684**.

The total amount of State General Revenue (SGR) funds shall not exceed \$168,881.

The total amount of funds committed by this **AGENCY** under this agreement shall not exceed **\$2,269,288**.
