Dear Jim,

As the City's designated representative for the Public Improvement District I am providing you the following enhancement to be amended into the Interlocal Agreement between the City and VIA regarding the overnight pressure washing of the downtown bus stop.

The enhancement involves an expansion of the nightly pressure washing of bus stops from five nights a week to seven by adding Friday and Saturday nights. This work will take place from 9:00pm to 5:30am. Below is a list of the 32 stops that will be pressure washed by the two Amigo crews. The annual cost for this expansion is \$69,000, which VIA will fund through its contract with the City that has been assigned by the City to Centro. VIA has agreed to fund this program \$15,000 for FY15. This will allow us to start this enhanced service on July 10<sup>th</sup>.
