AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF SUPPLEMENTAL FUNDS IN AN AMOUNT UP TO \$301,698.00 FROM THE ALAMO AREA COUNCIL OF GOVERNMENTS FOR THE SENIOR NUTRITION PROGRAM FOR THE PERIOD OF OCTOBER 1, 2014 TO SEPTEMBER 30, 2015.

WHEREAS, the City's Senior Nutrition Program (SNP) provides approximately 2,900 meals daily, Monday through Friday, to seniors ages 60 and older at 63 centers located throughout the Bexar County Area Agency on Aging service area; and

WHEREAS, the City, through the Department of Human Services, has operated the SNP using City General Fund and federal U.S. Department of Health and Human Services funds awarded by the Texas Department of Aging and Disability Services through the Alamo Area Council of Governments since 1973; and

WHEREAS, acceptance of the supplemental funds will support a total SNP budget of \$5,932,799.00, of which 39% is funded through the AACOG grant and 61% through the General Fund, and an additional 48,977 meals; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is authorized to accept supplemental funds in an amount up to \$301,698.00 from the Alamo Area Council of Governments for the Senior Nutrition Program for the period of October 1, 2014 to September 30, 2015, and to execute any and all documents necessary to effectuate acceptance of the additional funding. A copy of the original grant application is on file with DHS.

SECTION 2. Fund 2601138017, entitled, "SNP 2014-2015", and Internal Order 138000001281 is hereby designated for use in the accounting for fiscal transactions of the supplemental funds for the FY 2015 Senior Nutrition Program. The budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost

Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
