AUTHORIZING EXTENSION OF THE Α **COOPERATIVE** AGREEMENT THROUGH JANUARY 31. 2016, WITH THE TRANSPORTATION SECURITY **ADMINISTRATION** FOR CONTINUED LAW ENFORCEMENT OFFICER SUPPORT AT TERMINAL CHECKPOINTS OF SAN ANTONIO INTERNATIONAL AIRPORT.

WHEREAS, in 2012, the City entered into a three-year reimbursement grant agreement with the Transportation Security Administration (TSA) for the City to provide law enforcement officer support to each TSA Passenger Security screening checkpoint at San Antonio International Airport, and for the TSA to provide reimbursement for the salaries and benefits of the officers posted to the checkpoints; and

WHEREAS, this current cooperative agreement expires September 30, 2015; and

WHEREAS, the City is entering into a new cooperative agreement effective February 1, 2016, and requires the current cooperative agreement to be extended through January 31, 2016, to allow for continued law enforcement support at the terminal checkpoints; and

WHEREAS, it is now necessary to authorize the extension of the current cooperative agreement; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or the Aviation Director is hereby authorized to execute any and all necessary documents and take any actions necessary to effect the extension of the cooperative agreement with the Transportation Security Administration for continued law enforcement officer support at terminal checkpoints at the San Antonio International Airport through January 31, 2016. All steps previously taken by City staff to ensure timely submission of required documents to TSA are hereby ratified.

SECTION 2. The City Manager, or her designee, is hereby authorized to accept grant funds received from the Transportation Security Administration (TSA), to provide funding for continued law enforcement officer support at terminal checkpoints at the San Antonio International Airport through January 31, 2016.

SECTION 3. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
