WHEREAS, on June 3, 2008, the City entered into that certain *Professional Services Agreement* For Investment Training And Consultant Services ("Agreement") with Patterson Capital Management, L.P., d/b/a Patterson & Associates ("Patterson & Associates") under which Patterson & Associates has provided investment training and consultant services to the City and the City's Finance Department; and

WHEREAS, the most recent one (1) year renewal term of the Agreement expires on September 30, 2015; and

WHEREAS, City Staff has recommended that the Agreement be renewed and extended on the same terms and conditions for one (1) additional one (1) year term, to commence on October 1, 2015, and terminate on September 30, 2016; and

WHEREAS, upon consideration and deliberation of the matter, the City Council has determined that it is in the best interest of the City to extend the Contract; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Renewal And Extension Of Professional Services Agreement For Investment Training And Consultant Services ("Extension") between the City and Patterson & Associates is hereby approved in all things. A copy of the Extension is attached hereto as **Attachment I**. The Director of Finance is hereby authorized to execute the Extension on behalf of the City of San Antonio.

SECTION 2. All services heretofore provided by Patterson & Associates to the City under the Agreement, and all payments heretofore made by the City to Patterson & Associates in consideration for such services, are hereby ratified in all things.

SECTION 3. Funding for this ordinance in the amount of \$26,000.00 is contingent upon approval of the Fiscal Year 2016 Budget for Fund 11001000, Cost Center 0707010001 and General Ledger 5201040.

SECTION 4. Payment not to exceed the budgeted amount is authorized to Patterson and Associates and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance shall take effect immediately if passed by eight (8) affirmative votes; otherwise this Ordinance shall take effect ten (10) days from the date of passage hereof.

WHEREAS, the most recent one (1) year renewal term of the Agreement expires on September 30, 2015; and

WHEREAS, CITY now desires to renew and extend the Agreement on the same terms and conditions for one (1) additional one (1) year term, to commence on October 1, 2015, and terminate on September 30, 2016, and CONTRACTOR desires to do the same; NOW, THEREFORE

FOR VALUABLE CONSIDERATION, the Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

I. RENEWAL AND EXTENSION OF CONTRACT

1.1 The Agreement is hereby renewed and extended for a one (1) year term that commences October 1, 2015 and will terminate on September 30, 2016, in accordance with the provisions of Section 2.1 of the Contract.
