AN ORDINANCE

APPROVING CITY COUNCIL PROJECT FUND GRANTS IN EXCESS OF \$10,000.00 EACH TO THE PUBLIC LIBRARY FOUNDATION FOR THE MAYOR'S SUMMER READING PROGRAM; THE SAN ANTONIO PLAYHOUSE FOR EDUCATION NIGHTS AT THE PLAYHOUSE; THE DOSEUM (FORMERLY THE SAN ANTONIO CHILDREN'S MUSEUM) FOR LEARN & PLAY PASSES.

WHEREAS, the adopted FY 2015 budget provides for individual City Council district discretionary funds, commonly referred to as City Council Project Funds (CCPF) for programs, activities, events, scholarships, goods, or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 dated December 8, 2011 and updated pursuant to Ordinance 2013-11-7-0761; and

WHEREAS, the San Antonio Public Library Foundation hosts the Mayor's Summer Reading Program throughout the City's 26 branches to promote literacy which encourages children and teens to read at least 15 books over the summer and receive a certificate signed by the Mayor and a free book, and which Program served more than 30,000 youth, hosted nearly 2,000 programs, and distributed more than 10,000 books in 2014; and

WHEREAS, the San Antonio Playhouse produces Education Nights and wishes to provide complimentary tickets for students in each district attending middle and high school; and

WHEREAS, the Doseum (formerly the San Antonio Children's Museum) opened its 95,000 square-foot (indoor/outdoor), state of the art children's museum in the heart of the Broadway Cultural Corridor on June 6, 2015, and seeks CCPF grant allocations to help provide free Learn & Play passes for school groups, as well as camp program scholarships for eligible families; and

WHEREAS, the Mayor and City Council members from Districts 1, 2, 3, 4, 5, 6, 7, 8, and 10 desire to provide CCPF to the Public Library Foundation Mayor's Summer Reading Program, the Education Nights at The Playhouse, and Learn & Play passes for The Doseum in a total amount of \$32,218.18; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Funding to the San Antonio Public Library Foundation for the Mayor's Summer Reading Program in the amount of \$11,318.18 and any additional funding within this fiscal year, is hereby approved. SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
