AN ORDINANCE 2015-10-01-0848

WAIVING THE REQUIREMENTS OF SECTIONS 4-6(c)(1), 4-6(c)(2), 4-6(c)(3), 4-6(c)(4), 4-6(d)(1), 4-6(d)(6), AND 4-6(e)(1) OF THE CITY CODE AND AUTHORIZING THE SALE OF ALCOHOLIC BEVERAGES ON LOTS 10-12, 24-27, NCB 17725, GENERALLY LOCATED IN THE 17000 BLOCK OF JONES MALTSBERGER AND NORTH LOOP 1604 EAST FOR ON-PREMISE AND/OR OFF-PREMISE CONSUMPTION WITHIN THREE-HUNDRED FEET OF GREAT HEARTS ACADEMY CHARTER SCHOOL – NORTHERN OAKS CAMPUS, A PUBLIC EDUCATION INSTITUTION IN THE NORTHEAST INDEPENDENT SCHOOL DISTRICT, LOCATED IN COUNCIL DISTRICT 10.

WHEREAS, Section 109.33 of the Texas Alcoholic Beverage Code authorizes the governing board of an incorporated city to enact regulations prohibiting the sale of alcoholic beverages if the place of business is within three hundred feet of any church, public school or public hospital as measured in a direct line from the property line of the public or private school to the property line of the place of business; and

WHEREAS, Section 109.33 of the Texas Alcoholic Beverage Code authorizes the governing body of an incorporated city to allow variances to the regulation if the governing body determines that enforcement of the regulation in a particular instance is not in the best interest of the public, constitutes waste or inefficient use of land or other resources, creates an undue hardship on an applicant for a license or permit, does not serve its intended purpose, is not effective or necessary, or for any other reason the governing board, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community; and

WHEREAS, pursuant to Section 109.33 (a)(1) of the Texas Alcoholic Beverage Code, Chapter 4 of the City Code of the City of San Antonio prohibits the sale of alcoholic beverages if the place of business is within three hundred feet of any church, public school or public hospital; and

WHEREAS, the subject property is situated within three hundred (300) feet of the nearest property line of Great Hearts Academy Charter School – Northern Oaks Campus, thus, making the sale of alcoholic beverages a violation; and

WHEREAS, Ordinance No. 88724, passed and approved on October 22, 1998, amended the City Code of the City of San Antonio adopting this distance requirement in Chapter 4, Article I, Sec. 4-6, and established a procedure for the granting of a variance to the prohibition; and

WHEREAS, staff recommends any approval of the variance request contain the conditions that the authorization for the sale of alcoholic beverages shall be limited to no more than six establishments total and apply only to no more than two proposed "convenience stores" or "grocery stores," to no more than one proposed "wine boutique,". and to no more than three "restaurants," and that there shall be no "bars," "taverns," or "sexually-oriented businesses" on the property; that such approval contain conditions proposed by the applicant including that alcohol sales shall not exceed 30% of the total revenues for each such establishment other than the "wine boutique," that only beer and wine

shall be sold for off-premise consumption, and that alcohol sales shall not be permitted between the hours of 12:00 a.m. and 6:00 a.m.; that such approval not transfer different land uses, and that such authorization shall terminate in the event of non-operation or non-use of the identified establishments for a period of twelve (12) or more successive calendar months: NOW THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The requirements of Sections 4-6(c)(1), 4-6(c)(2), 4-6(c)(3), 4-6(c)(4), 4-6(d)(1), 6(d)(6), and 4-6(e)(1) prohibiting on-premise consumption pursuant to the City Code of the City of San Antonio are waived and the variance request of Brown & Ortiz, P.C., Applicant, to sell alcoholic beverages for on- and off-premise consumption at not more than six establishments, consisting of on and/or off-premise consumption at not more than two "convenience stores" or "grocery stores," not more than one "wine boutique," and not more than three "restaurants," and that there shall be no "bars," "taverns," or "sexually-oriented businesses" on the property, on lots 10-12, 24-27, NCB 17725, generally located in the 17000 block of Jones Maltsberger and North Loop 1604 East as shown on the accompanying map labeled "Attachment 1," within three hundred (300) feet of Great Hearts Academy Charter School - Northern Oaks Campus, is hereby granted. This variance to sell alcoholic beverages for on-premise and/or off-premise consumption is based on the following conditions: (a) that alcohol sales shall not exceed 30% of the total revenues for each such establishment other than the "wine boutique;" (b) that only beer and wine shall be sold for offpremise consumption; (c) that alcohol sales shall not be permitted between the hours of 12:00 a.m. and 6:00 a.m.; (d) that this authorization shall not transfer to different uses; (e) that such authorization shall terminate in the event of non-operation or non-use for a period of twelve or more successive calendar months;.

This Ordinance shall be effective immediately upon passage by eight or more **SECTION 2.** affirmative votes; otherwise, it shall be effective on the tenth day after passage.
