- Remove old detierating ceiling and paneling on walls & install new sheetrock. Then tape, float, texture & paint.
- Insulate house to make more energy efficient
- Replace 3 broken glass windows.
- Replace 2 broken ceiling fans that do not work.
- Replace 8 missing light fixtures.
- Replace 2 broken a/c window units
- Replace 1 broken toilet that leaks
- Repair original wood floors
- Replace restroom vanity and sink that are not salvageable.
- Replace kitchen cabinets that are not functioning properly

- Replace kitchen sink
- Install a kitchen vent hood, currently there isn't one
- Install new faucets in shower, restroom sink & kitchen sink, they current faucets leak.
- Repaint entire exterior of home including roof that was approved by Office of Historic Preservation.
- Install new driveway swinging gate to replace broken existing gate.
- Install a new privacy fence because old fence is leaning & rusted
- Level the garage floor with crushed rock so cars can be parked in garage
