

**INTEGRATION AGREEMENT FOR ANNUAL CONTRACT FOR  
SECURITY STAFFING SERVICES**

This Integration Agreement (Agreement) is entered into by and between the **CITY OF SAN ANTONIO, TEXAS**, a home-rule municipal corporation (City), by and through its Director of Finance or said Director's designee, and **ALLIED BARTON SECURITY SERVICES, LLC** (Allied Barton), both of which may be referred to herein collectively as the "Parties".

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

**1.0 CONTRACT DOCUMENTS**

The terms and conditions for performance and payment of compensation for this Agreement are set forth in the following contract documents, true and correct copies of which are attached hereto and fully incorporated herein for all purposes, and shall be interpreted in the order of priority as appears below:

- a. This Integration Agreement, including;
- b. Allied Barton's Best and Final Offer (BAFO) submitted to the City;
- c. City's RFCSP No.: 015-051; 6100005938, including all attachments and addendums thereto; and
- d. Allied Barton's proposal submitted in response to City's RFCSP .

**2.0 SECURITY OFFICER QUALIFICATIONS**

Allied Barton acknowledges and agrees that each Security Officer assigned to perform services under this Agreement will, prior to commencing the performance of such services and at all times while performing them, fully meet and satisfy each of the qualifications and requirements set forth in Section 004, D of the RFCSP, including but not limited to passing a Criminal Justice Information System ("CJIS") fingerprint-based background check.

**3.0 ENTIRE AGREEMENT**

This Agreement, together with the contract documents identified in Section 1.0 above constitutes the final and entire agreement between the Parties and contains all of the terms and conditions agreed upon. In the event of conflict between any provision(s) in the RFCSP and any provision(s) in the BAFO, the provision(s) in the BAFO shall prevail. No


