OF NO OBJECTION FOR THE FREEDOM HILLS RANCH APARTMENTS PROJECT APPLICATION TO THE STATE OF TEXAS 4% TAX CREDIT PROGRAM.

WHEREAS, Freedom SA Apartments, L.P., a Texas limited partnership (the "Applicant"), has proposed a 252 unit affordable rental housing development named Freedom Hills Ranch Apartments (the "Development"), to be located at 6010 Ray Ellison Drive, in the City of San Antonio, Texas (the "City"); and

WHEREAS, the Applicant has submitted an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2015 Private Activity Bonds and 4% Housing Tax Credits for the Development to be constructed for the San Antonio Housing Trust; and

WHEREAS, notice was provided to the City in accordance with Texas Government Code, Section 2306.67071; and

WHEREAS, the City has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development, and the Board of the San Antonio Housing Trust and the San Antonio Housing Trust Finance Corporation have given preliminary approval to the Development and the issuance of the bonds; and

WHEREAS, it is necessary that the City hold a hearing for comments to be made on the proposed Development in accordance with Texas Government Code, Section 2306.67071(b); and

WHEREAS, upon said hearing and after due consideration of the information provided by the Applicant and public comment, the City Council shall provide a Resolution of No Objection as required by the TDHCA 2015 Housing Tax Credit Application for the Development; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City certifies in accordance with the requirements of Texas Government Code §2306.67071 and Texas Administrative Code §10.204(4), it is hereby found that:

- (i) Notice has been provided to the City in accordance with Texas Government Code, §2306.67071(a); and
- (ii) The City has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and
- (iii) The City has held a hearing at which public comment may be made on the proposed Development in accordance with Texas Government Code, §2306.67071(b); and

(iv) After due consideration of the information provided by the Applicant and public comment, the City does not object to the proposed Application.

SECTION 2. The City hereby confirms that it does not object to the Application to the Texas Department of Housing and Community Affairs for the proposed Freedom Hills Ranch Apartments Project, 6010 Ray Ellison Drive, San Antonio, Texas.

SECTION 3. That for and on behalf of the City Council, the City Clerk is hereby authorized, empowered, and directed to certify this Resolution to the Texas Department of Housing and Community Affairs.

SECTION 4. This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
