AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$1,573,200.00: (A) MIDWEST **VETERINARY SUPPLY AND** PATTERSON VETERINARY FOR VETERINARIAN PHARMACEUTICALS AND VACCINE SUPPLIES, (B) STRYKER SALES CORPORATION FOR THE PURCHASE & MAINTENANCE OF AMBULANCE STRETCHERS, COMBINATION CHAIRS & COT HOLDERS, (C) UNGERBOECK SOFTWARE INTERNATIONAL, INC. **UNGERBOECK** FOR MAINTENANCE & SUPPORT, AND (D) CARTEGRAPH SYSTEMS, INC. FOR CARTEGRAPH UPGRADES TO INCLUDE MAINTENANCE AND SUPPORT.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, this ordinance approves two low bid contracts, one contract which provide for a procurement necessary to protect the public health or safety, and two sole source contracts; and

SECTION 1. The bids of the following companies to furnish the City with: (A) Midwest Veterinary Supply and Patterson Veterinary for veterinarian pharmaceuticals and vaccine supplies, (B) Stryker Sales Corporation for the purchase & maintenance of ambulance stretchers, combination chairs & cot holders, (C) Ungerboeck Software International, Inc. for Ungerboeck maintenance & support, and (D) Cartegraph Systems, Inc. for Cartegraph upgrades to include maintenance and support on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.
