AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$5,451,000.00: (A) ARGUINDEGUI OIL COMPANY, ARNOLD OIL COMPANY OF AUSTIN, LP, GENUINE PARTS COMPANY AND HAYS CITY CORP. DBA TEX-CON OIL CO. FOR LUBRICANTS, (B) OXFORD IMMUNOTEC, INC. FOR TB TEST KITS AND SUPPLIES, (C) BOUND TREE MEDICAL, LLC AND LIFE-ASSIST, INC. FOR EMS MEDICATIONS AND EQUIPMENT, AND (D) T & W TIRE FOR AMENDMENT III TO CONTRACT FOR EMERGENCY TIRES.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, these bids are from the following companies to furnish the City with: (A) Arguindegui Oil Company, Arnold Oil Company of Austin, LP, Genuine Parts Company and Hays City Corp. d/b/a Tex-Con Oil Co. for lubricants, (B) Oxford Immunotec, Inc. for TB test kits and supplies, (C) Bound Tree Medical, LLC and Life-Assist, Inc. for EMS medications and equipment, and (D) T & W Tire for amendment III to contract for emergency tires; and

WHEREAS, this ordinance approves four low bid contracts, two contracts which provide for a procurement necessary to protect the public health or safety, one sole source contract, and one contract amendment; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids of the following companies to furnish the City with: (A) Arguindegui Oil Company, Arnold Oil Company of Austin, LP, Genuine Parts Company and Hays City Corp. d/b/a Tex-Con Oil Co. for lubricants, (B) Oxford Immunotec, Inc. for TB test kits and supplies, (C) Bound Tree Medical, LLC and Life-Assist, Inc. for EMS medications and equipment, and (D) T & W Tire for amendment III to contract for emergency tires on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as Exhibit I. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.
