# Mayor's Task Force Recommendation – Manufactured Homes

Natalie Griffith asked if this would include modular homes.

<u>Richard Milk</u> stated the tool has a broader application than mobile/manufactured home communities and would want to look at Land Trust in a broader context.

<u>Natalie Griffith</u> requested information on the mobile home development near Toyota. The infrastructure was built but development was stopped.

Michael Taylor stated staff will look into that particular project.

<u>Richard Milk</u> asked if there are manufactured parks that have a purchase option.

<u>Michael Taylor</u> stated there are no purchase options in the City of San Antonio. In order for someone to purchase the land it would need to be subdivided and meet lot requirements. For manufactured homes it would need to be on a 4000 square foot lot.

# **Existing Policies – State**

### **Existing Policies – Local**

Jim Bailey stated he will go through the UDC to do a couple of sketch studies and see what is possible and what is not possible within the existing code.

<u>Catherine Hernandez</u> stated the difference between the two is virtually no difference. We use MHP for the parks and the other one is manufactured housing conventional district. The standards within it are virtually the same.

### Christopher Lazaro presented.

<u>Carol Rodriguez</u> asked if more research is needed around the finance availability. The finance aspect could impact policies moving forward.

Natalie Griffith suggested inviting someone that finances manufactured homes.

### **Protecting Manufactured Home Communities – Best Practices**

<u>Richard Keith, Department of Human Services</u>, referring to the Mission Road Mobile Home Park, nearly all the individuals that were placed went to a stable condition. For nearly nine months Human Services spent time with the families to discuss their placement options.

Jim Bailey stated there needs to be a threshold that triggers city intervention, a determination where it's either viable or unviable community as it stands without significant immediate public investment.

<u>Carol Rodriguez</u> stated before looking at the viability of a mobile home park, we need to look at where the investments are happening that are already pointing to that being the next mobile home park.

Jennifer Gonzalez requested a copy of the Fort Collins, Co. mobile home redevelopment services plan.

#### **Policy Options**

<u>Richard Milk</u> stated the primary option is to protect but if the owner decides to sell, which the owner has that right, then there the two options on the table.

<u>Natalie Griffith</u> stated you can take out the manufactured out of the policy options. The policies should be for any kind of rental.

<u>Michael Taylor</u> stated the hope is to identify the area's most vulnerable then we can take the step looking at viability.
