RATIFYING A CONTRACT WITH PERENNIAL ENERGY, LLC FOR PROVIDING THE UPGRADE TO THE EXISTING RIGSBY LANDFILL GAS CANDLESTICK FLARE STATION FOR A TOTAL COST OF \$81,202.00, FUNDED FROM THE SOLID WASTE MANAGEMENT DEPARTMENT OPERATING AND MAINTENANCE FUND.

WHEREAS, an offer was submitted by Perennial Energy, LLC to provide the City of San Antonio Solid Waste Management Department with an upgrade to the existing Rigsby Landfill Gas Candlestick Flare Station for a total cost of \$81,202.00; and

WHEREAS, the Flare Station is necessary to flare methane and provide migration control to protect the adjacent property owners from methane migration; and

WHEREAS, a fire damaged some of the flare components and safety controls of the existing Flare Station, and repair was rendered impossible due to obsolete parts; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The contract with Perennial Energy, LLC to provide the City of San Antonio Solid Waste Management Department with an upgrade to the existing Rigsby Landfill Gas Candlestick Flare Station for a total cost of \$81,202.00 is hereby ratified.

**SECTION 2.** Funding in the amount of \$81,202.00 is available in Fund 55001000, Cost Center 5556020001 and General Ledger 5204080 as part of the FY 2015 Carry Forward. Payment not to exceed the budgeted amount is authorized to Perennial Energy, LLC and should be encumbered with a purchase order.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.
