## AN ORDINANCE 2016-02-11-0072

AUTHORIZING A TASK ORDER CONSTRUCTION CONTRACT WITH E-Z BEL CONSTRUCTION, LLC IN THE AMOUNT NOT TO EXCEED \$2,613,283.97 FOR THE INSTALLATION OF TRAFFIC SIGNAL SYSTEMS AND OTHER DEVICES THROUGHOUT THE CITY.

WHEREAS, throughout each year, traffic signals and other projects are constructed to address specific traffic or pedestrian safety needs which include, but are not limited to, the installation of traffic signals, pedestrian hybrid beacons, school flashers, Intelligent Transportation System (ITS) devices, and any other related work; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in the amount not to exceed \$2,613,283.97 for construction work associated with the installation of Traffic Signal Systems and other devices throughout the City; and

WHEREAS, the term shall commence on February 11, 2016 and terminate on February 11, 2019; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The lowest responsive bid of **E-Z Bel Construction, LLC** in the amount not to exceed \$2,613,283.97 for installation of Traffic Signal Systems and other devices throughout the City is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

**SECTION 2.** A task order construction contract is hereby awarded to **E-Z Bel Construction**, **LLC.** 

**SECTION 3.** The following financial adjustment is hereby approved:

- a) Funding for this ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with Operating and/or Capital Budgets for current and future fiscal years.
- b) Payment not to exceed \$2,613,283.97 per contract is authorized to be encumbered with a purchase order and made payable to **E-Z Bel Construction**, **LLC**, for the projects pertaining to the installation of traffic signals, pedestrian hybrid beacons, school flashers, Intelligent Transportation System (ITS) devices, and any other related work throughout the City.

c) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.

SECTION 5. PASSED AND APPROVED this 11th day of February, 2016.
