AN ORDINANCE 2016-03-10-0207

APPROVING A PAY ADJUSTMENT TO THE SALARY OF THE CITY AUDITOR TO PROVIDE FOR A PERFORMANCE PAY INCREASE.

* * * * *

WHEREAS, the City Council Audit Committee evaluated the performance of the City Auditor at its meeting on February 16, 2016, and reported its evaluation to the full City Council on March 2, 2016; and

WHEREAS, as a result of the evaluation, City Council now wishes to provide for and approve a specific pay adjustment for the City Auditor; and

WHEREAS, the salary and benefits of the City Auditor are included in the Operating Budget of the City Auditor's Office; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Auditor shall receive a 5% pay adjustment, which establishes his annual salary at \$167,076, in recognition of performance in FY2015.

SECTION 2. The salary and benefits of the City Auditor are included in the FY 2016 Operating Budget of the City Auditor's Office.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
