AN ORDINANCE 2016-03-31-0231

ADJUSTING THE SALARY OF THE CITY CLERK TO PROVIDE FOR A 5% ADJUSTMENT IN ACCORDANCE WITH CITY COUNCIL'S EVALUATION OF THE CITY CLERK'S PERFORMANCE, EFFECTIVE JANUARY 1, 2016.

WHEREAS, City Council recently evaluated the performance of the City Clerk; and

WHEREAS, appropriations to provide pay adjustments for the City Clerk were included in the FY2016 Budget; and

WHEREAS, it is now necessary to provide for and approve a specific pay adjustment for the City Clerk; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Clerk shall receive a 5% pay adjustment based on the City Council evaluation of the City Clerk's performance, effective January 1, 2016.

SECTION 2. Appropriations for the salary adjustments provided in this Ordinance were included in the FY2016 Budget, approved September 10, 2015.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
