The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

1. The Invocation was delivered by Keely Petty, Pastor, Bethel International Christian Fellowship, guest of Councilmember Alan E. Warrick, II, District 2.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the Regular City Council Meetings of January 13 - 14, 2016.

Councilmember Warrick moved to approve the Minutes for the Regular City Council Meetings of January 13-14, 2016. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

**POINT OF PERSONAL PRIVILEGE**

Mayor Taylor recognized Pedro Rodriguez Zaragoza, Vice-Regional Minister of External and Foreign Affairs, Canary Islands Government, as well as his Delegation of Civic and Cultural Leaders. She welcomed them to San Antonio and stated that she looked forward to a continued relationship between the two cities. Mr. Zaragoza thanked Mayor Taylor and stated that he looked forward to her visit to the Canary Islands in the near future. Councilmembers Krier and Treviño also welcomed the visitors to San Antonio.

Councilmember Gallagher invited everyone to attend the El Camino Real Project Completion Ceremony the next day at 10:00 am at Comanche Lookout Park.

**CONSENT AGENDA ITEMS**

Items 4, 12, 13, and 15 were pulled for Individual Consideration. Mayor Taylor announced that Item 17 was pulled from the agenda by staff. Councilmember Medina moved to approve the remaining Consent Agenda Items. Councilmember Lopez seconded the motion.

Mayor Taylor called upon Mr. Jack M. Finger to speak.

Mr. Jack M. Finger asked if the Veteran's Outreach Center proposed in Item 15 would offer services already provided to Veterans. He asked if Sports Venues in San Antonio are profitable (Item 18). He expressed concern with the subsidizing of the Multi-Family Affordable Rental Housing Development (Item 20).

Faris Hodge, Jr. submitted written testimony in favor of Items 4-6, and 8-19. He wrote in opposition to Item 7.

City Clerk Vacek read the caption for Item 4:

Councilmember Medina asked if this would alleviate some of the concerns inside the parks. Art Reinhardt replied that it was outside of the Park Areas through the Natural Creekways

and part of the Infrastructure Management Program. Councilmember Medina brought attention to work that is needed in the parks where the tributaries come through; specifically around O.P. Schnabel Park.

Councilmember Medina moved to adopt the proposed Ordinance for Item 4. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 12:

- 12.** An Ordinance amending chapter 13 of the City Code entitled “Food and Food Handlers” to adopt the new Texas Food Establishment Rules and to further revise the regulation of food establishments, and providing for penalties and publication. [Erik Walsh, Deputy City Manager; Dr. Vincent R. Nathan, Interim Health Director]

Councilmember Viagran asked for a presentation on said item. Dr. Vincent Nathan presented a Power Point and stated that the objectives of the Chapter 13 Amendments were to increase public awareness, ensure transparency, increase food safety, and ensure long-term restaurant compliance. He stated that they held five meetings with stakeholders to include the San Antonio Hotel and Lodging Association and San Antonio Restaurant Association. He outlined the updated recommendations: 1) Adopt the new Texas Food Establishment Rule as set forth by the Department of State Health Services effective April 1, 2016; 2) Mandatory Food Handler Certification effective October 1, 2016; 3) Implement a Grading System that translates the current demerit score to a 100 Point Scale; and 4) Implement a Voluntary Placard Program. He spoke of the new Inspection Report that must be posted in clear sight of the public upon entry. He noted that they would monitor the program and provide a performance update in the first quarter, as well as provide training for staff. He added that staff further recommended that they allow Temporary Food Establishments at Farmers Markets to operate two days a week per calendar month and remove the ability to transfer permits from one location to another. Councilmember Viagran stated that she was pleased with the changes to Farmers Markets and the New Placard System.

Councilmember Treviño thanked everyone for their work and asked how the recommendation not to allow Farmers Market Permits to transfer from one location to another would affect the Downtown Night Market. Dr. Nathan replied that they were working with them to better understand their issues. Councilmember Treviño asked how long that process would take. Erik Walsh replied that they would work through the issues

as quickly as possible and hoped to present an update to the Neighborhoods and Livability Council Committee in April.

Councilmember Treviño moved to adopt the proposed Ordinance for Item 12. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 13:

- 13.** An Ordinance amending Article I (General Provisions), Article IV (Horse-Drawn Carriages), Article V (Limousine Services), Article VI (Pedicab Services), Article VII (Tour and Charter Service) and Article VIII (Taxicabs) and adding Article III (Group Cycle Services) to Chapter 33 of the City Code of San Antonio, Texas, to amend the definitions, modify the procedures and regulations relating to operating permits, drivers permits and vehicles, allow for equine drawn carriages, modify certain fees, and to adopt rules and regulations for the operation of group cycles, with penalties for violations. [Erik Walsh, Deputy City Manager; William McManus, Chief of Police]

Mayor Taylor called upon the citizens registered to speak.

Mitsuko Ramos stated that she represented Elegant Limousine and Charter Service in support of the Amendments to Articles I, V, and VII that impact the Limousine Service Industry.

Robert Gonzales of National Cab and a Member of the Transportation Advisory Board stated that he had served on a Subcommittee related to the Taxicab Industry. He noted that they were in support of the amendments; however, there was still some additional work to be done to include reducing fees paid by the Taxicab Industry.

Leah Burt stated that she and her husband owned a small Limousine Company and they did not support all of the amendments. She noted concerns that they were required to have a Limousine since the demand was for Sedans and Sport Utility Vehicles (SUVs). She expressed concern that Uber Black was exempt from the rule and with the high fees they were required to pay. She mentioned that her husband could not drive for a Transportation Network Company (TNC) as he was required to have personal insurance. She further expressed concern that TNCs did not pay Ad Valorem Taxes on their fleet.

Marvin Peretz stated that he has been a Taxicab Driver for 7 years and was speaking in opposition to the amendments. He expressed concern that he could not compete against TNCs in a fair manner and requested that the amendments be looked at comprehensively.

John Bouloubasis stated that he supported the changes to the Ordinance being presented today but added that there were other changes that needed to occur in order for the Industry to be more competitive.

Mohammad Amrollah stated that he has been a Taxicab Driver for 35 years and that he hopes that the City Council gives the Taxicab Industry the same consideration given to the TNCs. He added that the issues brought up today should be considered sooner not later.

Councilmember Krier asked of the update regarding TNCs and if there had been any complaints since the Ordinance was adopted. Chief Baum replied that the update was scheduled to be presented to the City Council in June. Councilmember Krier stated that the playing field should be leveled for the Taxicab and Limousine Industry. Chief Baum outlined revisions to Chapter 33 to include aligning Insurance Requirements for Vehicles for Hire to match State Requirements and extending Vehicle Replacement Requirements from 8 years to 12 years. He added that adjustments to the fee schedules were not included but would bring those recommendations back in June. Councilmember Krier thanked Councilmember Viagran for her leadership on the Criminal Justice, Public Safety, and Services Council Committee.

Councilmember Viagran thanked the Members of the Criminal Justice, Public Safety, and Services Council Committee for their work and highlighted changes to Chapter 33 to include extending Driver Permit Times and Vehicle Life. She stated that other revisions would be recommended after the 9-Month Review of TNCs in June. She noted the many public meetings held regarding the recommended changes and added that Public Safety must stay at the forefront for Visitors and Residents.

Councilmember Nirenberg noted Driving While Intoxicated Statistics in Bexar County and asked of next steps for TNCs. Chief Baum replied that they would be holding two Town Hall Meetings to solicit input from the community regarding TNC Operations. He noted that they would also be meeting with the Transportation Advisory Board and Industry Representatives over the next few months. Councilmember Nirenberg stated that he would like to have a B Session in order to get input from the full City Council.

Councilmember Gallagher spoke of the importance of public safety and stated that it was necessary to move forward with a fair and balanced approach. He added that they needed



to address the impact to the Limousine and Taxicab Industry.

Councilmember Treviño asked of the two Town Hall Meetings. Erik Walsh stated that they were in the process of designing the structure and hoped to host one before Fiesta. He noted that they would hold another after Fiesta and would publicize the dates and locations. Councilmember Treviño stated that he was pleased that they were being proactive and inclusive and looked forward to a successful discussion on same. Mayor Taylor added that she was confident that they were taking the right approach in terms of involving stakeholders and the various levels of vetting. She thanked everyone for their work.

Councilmember Krier moved to adopt the proposed Ordinance for Item 13. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 15:

- 15.** An Ordinance authorizing a second amendment to the funding agreement with Alamo Community College District to provide for funding an amount not to exceed \$5,070,426.00; the acceptance of a \$500,000.00 grant from the Greehey Family Foundation; an Interlocal Agreement with Alamo Colleges and San Antonio Housing Authority for a \$600,000.00 Department of Housing and Urban Development Grant; and a Funding Agreement with the Inner City Tax Increment Reinvestment Zone Number Eleven Board of Directors and Alamo Colleges in an amount not to exceed \$950,000.00 for the planned renovations to the Good Samaritan Hospital Building to operate as a Veterans Outreach and Transition Center located on the 1600 block of Dakota street in Council District 2. [Lori Houston, Assistant City Manager, John Jacks, Interim Director, Center City Development and Operations]

Mayor Taylor noted that there were a few new Councilmembers that were not here when this project was implemented and asked staff for a presentation. John Jacks presented a Power Point regarding the Veterans Outreach and Transition Center. He stated that they were requesting approval of the following: 1) Agreement with the Inner City Tax Increment Reinvestment Zone (TIRZ) for \$950,000; 2) Acceptance of \$500,000 from the Greehey Family Foundation; 3) Second Amendment to the Funding Agreement with Alamo Colleges in the amount of \$5,070,426 for construction of the Veterans Outreach and Transition Center; and 4) Tri-Party Agreement among the City of San Antonio, Alamo Colleges, and the San Antonio Housing Authority in the amount of \$600,000. He outlined the project source of funds and use of the funds and showed before and after photos of the building.

Mayor Taylor stated that she was excited to see the item on the agenda today noting that it had taken several years to get to this point. She noted that the project would not have been possible without the support from Bill Greehey, as well as the Alamo Colleges and Senator Menendez. She added that she looked forward to seeing the completion of the facility and Veterans obtaining the help that they need.

Councilmember Warrick commended Mayor Taylor for her leadership on the project and recognized Tomas Larralde representing Senator Menendez. Mr. Larralde stated that Senator Menendez was pleased to help secure funding for the project and commended Mayor Taylor for her hard work on the project since she was a Councilmember. He read a statement from Senator Menendez thanking the City Council for their foresight and noting that he hoped to continue the partnership in the future. Councilmember Warrick acknowledged staff for their work.

Councilmember Krier highlighted Mr. Greehey for the funding and support for the project and also recognized Councilmember Nirenberg for his efforts on addressing Veteran Homelessness. Councilmember Viagran stated that she was pleased to support Veterans and that she would like to have a similar facility in District 3.

Councilmember Medina commended Mayor Taylor for her leadership and commitment to the Veterans in San Antonio. Councilmember Gonzales expressed her support and confirmed that the original structure would remain. Mr. Jacks stated that the Historic Façade in the front of the building would remain.

Councilmember Warrick moved to adopt the proposed Ordinance for Item 15. Councilmember Krier seconded the motion. The motion prevailed by the following vote:

## **22. City Manager's Report**

### **A. Infrastructure Management Program Update**

### **B. 9th Annual City Manager's Step Up To Wellness 5K Walk & Run**

A. Mrs. Sculley provided an update on the Infrastructure Management Program (IMP) noting that the IMP was a 5-Year Program of Infrastructure Projects for streets, alleys, and sidewalks. She noted that the IMP includes signal and intersection improvements, bicycle routes, pedestrian safety improvements, and drainage improvement projects. She reported that the FY 2016 IMP has over 1,200 projects totaling \$88 Million. She mentioned that the

majority of the IMP was funded with the General Fund, Advanced Transportation District (ATD) Funds, and the Storm Water Utility Fee. She stated that this year, an additional \$33 Million for streets and sidewalks was approved in the Budget. She noted that Streets Maintenance Funding increased by 56% or \$23 Million over FY 2015 Funding Levels and totals \$64 Million. She added that Sidewalk Funding increased by \$10 Million over FY 2015 Funding Levels and totals \$15 Million. She reported that at the conclusion of FY 2016; nearly 300 miles of streets will be improved and over 30 miles of neighborhood sidewalks will be constructed. She added that the IMP was a key program supporting the City's Vision Zero Initiative led by Councilwoman Gonzales. She indicated that \$16.6 Million was allocated in the FY 2016 IMP toward sidewalks, bike lanes, pedestrian safety, and intersection projects designed to enhance safety and accessibility which are key elements of Vision Zero. She stated that the delivery of the FY 2016 IMP was on schedule and within Budget. She noted that the peak of work would be performed in April, May and June when an estimated 385 projects will be delivered. She mentioned that the 1,200 projects in the FY 2016 IMP were listed on the City's TCI Website.

B. Mrs. Sculley reported on the results of the 9th Annual City Manager's Step Up To Wellness 5K Walk & Run that took place on Saturday, February 27, 2016 at SeaWorld San Antonio. She stated that this year's event marked the greatest number of Event Day Participants which totaled 2,047. She highlighted the City's Employee Wellness Program and stated that more than 4,500 Employees were participating in the Virgin Pulse Pedometer Program. She noted that utilization of the City's Employee Assistance Program was higher at 9% versus the National Average of 4.5%. She mentioned the various awards the City had been recognized for including the 2015 National Healthiest 100 Employers Award.

#### **POINT OF PERSONAL PRIVILEGE**

Mayor Taylor recognized Acting City Attorney Martha Sepeda who would be celebrating her birthday on March 8, 2016. The City Council wished Ms. Sepeda a Happy Birthday.

Mayor Taylor recessed the meeting at 10:55 am and announced that the meeting would resume at 2:00 pm for Zoning.

#### **RECONVENED**

Mayor Taylor reconvened the meeting at 2:06 pm.

Councilmember Nirenberg recognized Former Councilmember Jimmy Hasslocher. Mr. Hasslocher stated that he was pleased to support Item Z-11 and to partner with the City of

San Antonio. Councilmember Nirenberg stated that the building was being transformed to include a Helistop and thanked Mr. Hasslocher for his leadership. Mayor Taylor also thanked Mr. Hasslocher for his work in the community.

### **CONSENT ZONING ITEMS**

Zoning Items P-1, Z-1, Z-3, Z-7, and Z-12 were pulled for Individual Consideration. Councilmember Gallagher moved to approve the remaining Consent Zoning Items. Councilmember Viagran seconded the motion.

Mayor Taylor called upon the citizens registered to speak.

Jack M. Finger spoke in opposition to the Alcohol Variance requested in Item 23 due its close proximity to Cornerstone Christian School–Kinder Campus. He stated that he was opposed to Items P-1 and Z-1 noting that the Zoning Commission had denied the request. He added that he was against the Pawn Shop requested in Item Z-7.

Rachel Delgado stated that she lived at 4537 Monterrey Street and would like to have her family home designated Historic (Item Z-9). She noted that the home was 65 years old and had maintained its integrity.

The motion to approve the remaining Consent Zoning Items prevailed by the following vote:
