

AN ORDINANCE 2016-04-14-0274

AMENDING A PROFESSIONAL SERVICES AGREEMENT WITH PAPE-DAWSON ENGINEERS, INC. IN THE AMOUNT NOT TO EXCEED \$56,920.00 FOR ADDITIONAL CONSTRUCTION PHASE SERVICES RELATED TO THE ESPADA ROAD – LOOP 410 TO E. ASHLEY ROAD PROJECT, 2017-2022 GENERAL OBLIGATION BOND FUNDED PROJECT LOCATED IN COUNCIL DISTRICT 3.

WHEREAS, the Espada Road - Loop 410 to E. Ashley Road Project was included in the 2012-2017 Bond Program, and was part of the original Mission Trails Enhancement Project and is located within the limits of the recently designated World Heritage Site in San Antonio; and

WHEREAS, as part of this designation, this project will be consistent with the World Heritage vision and aesthetics that are being developed in order to identify the sites and buffer areas; the characteristic elements to be use for this project will include the installation of colored paver bands along the street, decorative street lighting, iconic monuments, Mission Trails way-finding signage, and bike lanes and shared-use lanes as part of the Mission Trails hike and bike routes; and

WHEREAS, this project is located within the nationally listed Mission Parkway Historic District and is in compliance with the Texas Parks & Wildlife Code, Title 3, Chapter 26, which requires proper planning to minimize harm to land designated as a historic site/district. This project is also in coordination with the Mission Trails Oversight Committee, the San Antonio Parks Department, the National Park Service, and the San Antonio Area Tourism Council; and

WHEREAS, a previously executed contract with **Pape Dawson Engineers, Inc.** was approved by City Council through Ordinance 2011-11-17-0938 for the Espada Road Project; and

WHEREAS, this Ordinance amends the professional services agreement with **Pape-Dawson Engineers, Inc.** in the amount not to exceed \$56,920.00 for additional Construction Phase Services related to the Espada Road - Loop 410 to E. Ashley Road Project; and

WHEREAS, this is a one-time capital improvement expenditure in the amount not to exceed \$56,920.00 to provide additional Construction Phase Services related to the Espada Road - Loop 410 to E. Ashley Road Project for which funds are available in previously authorized 2012 General Obligation Bond funds; and, included in FY 2016 - 2021 Capital Improvements Program Budget; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The Professional Services Agreement with **Pape Dawson Engineers, Inc.** is hereby amended in the amount not to exceed \$56,920.00 to provide additional construction phase services for the Espada Road - Loop 410 to E. Ashley Road Project.

SECTION 2. Payment in the amount not to exceed \$56,920.00 in SAP Fund 45099000, General Obligation Capital, SAP Project Definition 40-00246, Espada Road - IH 410 to E. Ashley Road, is authorized to be encumbered and made payable **Pape-Dawson Engineers, Inc.** for professional design services.


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
