

AN ORDINANCE 2016-04-14-0285

AUTHORIZING A THREE (3) YEAR EXTENSION OF AN AGREEMENT FOR AUDIO VISUAL AND RIGGING SERVICES AT THE HENRY B. GONZALEZ CONVENTION CENTER WITH AUDIO VISUAL SERVICES GROUP D/B/A PSAV PRESENTATION SERVICES.

WHEREAS, On April 21, 2010, following the issuance of a Request for Qualification ("RFQ") and the recommendation of a City evaluation committee, the City Council approved a five (5) year Agreement for Audio Visual and Rigging Services at the Henry B. Gonzalez Convention Center (the "Agreement") with Audio Visual Services Group d/b/a PSAV Presentation Services ("PSAV"); and

WHEREAS, the Agreement provides for a three (3) year extension upon the concurrence of PSAV and the City, evidenced by the passage of a duly authorized City ordinance; and

WHEREAS, City staff is recommending the extension of the Agreement, which provides for PSAV to operate as the City's "preferred" contractor on a non-exclusive basis until April 21, 2019; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of a three (3) year extension to the Agreement for Audio Visual and Rigging Services at the Henry B. Gonzalez Convention Center are hereby approved. A copy of the extension shall be attached to this Ordinance as Exhibit A upon execution by all parties.


SECTION 2. The City Manager or her designee is hereby authorized to execute an extension agreement with PSAV as described in Section 1 above to extend the current Agreement for Audio Visual and Rigging Services at the Henry B. Gonzalez Convention Center for an additional three (3) year period.

SECTION 3. This Ordinance shall become effective immediately upon its passage by eight (8) affirmative votes of the City Council.



**RENEWAL OF THE AGREEMENT FOR AUDIO VISUAL AND RIGGING
SERVICES AT THE HENRY B. GONZALEZ CONVENTION CENTER**

**BETWEEN THE CITY OF SAN ANTONIO AND AUDIOVISUAL SERVICES
GROUP, INC. d/b/a PSAV PRESENTATION SERVICES**

This RENEWAL OF THE AGREEMENT FOR AUDIO VISUAL AND RIGGING SERVICES AT THE HENRY B. GONZALEZ CONVENTION CENTER (this "Renewal") is entered into by and between the City of San Antonio (the "City") and AUDIOVISUAL SERVICES GROUP, INC. d/b/a PSAV Presentation Services ("Contractor") together referred to as "the Parties."

RECITALS

- A. City and Contractor are parties to that certain AGREEMENT FOR AUDIO VISUAL AND RIGGING SERVICES AT THE HENRY B. GONZALEZ CONVENTION CENTER (the "Agreement") authorized by City of San Antonio Ordinance No. 2011-04-21-0320, passed and approved on April 21, 2011.
- B. Prior to the effectiveness of this Renewal, the Agreement terminates at midnight central standard time on April 30, 2016.
- D. City and Contractor, in accordance with Section 2.2 of the Agreement, desire to renew the term of the Agreement for one additional three (3) year period commencing on May 1, 2016.
- E. All other provisions of the Agreement shall remain in full force and effect.

RENEWAL

NOW THEREFORE, City and Contractor hereby agree and amend as follows:

- 1. Definitions. All capitalized terms used in this Renewal without definition herein shall have the meanings assigned to such terms in the AGREEMENT.
- 2. Renewal. The Parties hereby agree to renew the Agreement in accordance with Section 2.2.
 - (a) The renewal term shall commence on May 1, 2016.
 - (b) The renewal term shall terminate at midnight central standard time on May 1, 2019.
- 3. Effective Date. This Renewal shall be effective May 1, 2016.

4. No Other Changes. Except as specifically set forth in this Renewal, all of the terms and conditions of the Agreement shall remain the same and are hereby ratified and confirmed. The Agreement shall continue in full force and effect and with this Renewal shall be read and construed as one instrument.

5. Choice of Law. This Renewal shall be construed in accordance with and governed by the laws of the State of Texas.

6. Counterparts. This Renewal may be executed in any number of counterparts, but all such counterparts shall together constitute but one instrument. In making proof of this Renewal it shall not be necessary to produce or account for more than one counterpart signed by each party hereto by and against which enforcement hereof is sought.
