WHEREAS, bids were submitted to provide the City of San Antonio's Parks & Recreation, Center City Development & Operations, and Aviation Departments with light utility vehicles for daily operations, grounds keeping maintenance, and project support throughout the City; and

WHEREAS, Mission Golf Cars submitted the lowest bids for items 1 and 3 for a total cost of \$25,051.00; and

WHEREAS, the lowest bid for item 4 was submitted by Ewald Kubota Tractor for a cost of \$51,077.76; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids submitted by Mission Golf Cars (Items 1 and 3) and Ewald Kubota Tractor (Item 4) to provide the City with light utility vehicles for a total cost of \$76,128.76 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as **Exhibit I** is the bid tabulation sheet. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.
