WHEREAS, City Council desires to initiate a change in the zoning district boundary for property in the Hot Wells Neighborhood, generally located within the boundaries of East Southcross Boulevard to the north; Highway 281 South to the east; Koehler Court, Wahrmund Court and Story Lane to the south; and South Presa Street to the west, to a zoning district consistent with the current land use and the surrounding neighborhood in accordance with the Texas Local Government Code Chapter 211 and Chapter 35 of the City Code of San Antonio, Texas, as requested by Councilmember Rebecca Viagran, District 3; NOW THEREFORE;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. City Council hereby directs City staff to initiate a change in the zoning district boundary for property in the Hot Wells Neighborhood, generally located within the boundaries of East Southcross Boulevard to the north; Highway 281 South to the east; Koehler Court, Wahrmund Court and Story Lane to the south; and South Presa Street to the west to a zoning district consistent with the current land use and the surrounding neighborhood.

SECTION 2. This resolution shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
