

FIELD NOTES OF TRACT 2 (109.955 ACRES)

A 109.955 acre, or 4,789,626 square feet more or less, tract of land being a portion of a 111.215 acre tract of land conveyed to CSS7 Ranches Limited Partnership in deed recorded in Volume 14997, Pages 1174-1179 of the Official Public Records of Real Property of Bexar County, Texas, out of a 1,200 acre tract of land conveyed to Leslie W. Steubing in deed recorded in Volume 3513, Page 145 of the Deed Records of Bexar County, Texas, situated in the A. Houston Survey No. 93, Abstract 355, County Block 4937, and the A. Houston Survey No. 94, Abstract 356, County Block 4938, both now in New City Block 19221 of the City of San Antonio in Bexar County, Texas. Said 109.955 acre tract being more fully described as follows, with bearings based on the Texas Coordinate System established for the South Central Zone from the North American Datum of 1983 (NA2011) epoch 2010.00:
