Biography

Marco A. Barros

President & CEO San Antonio Area Tourism Council

Marco A. Barros is president/CEO of the San Antonio Area Tourism Council. The Tourism Council is a private sector organization comprised of hotels, attractions, museums, car rental agencies, airlines, restaurants, transportation companies, tour operators, meeting planners, vendors and suppliers to the industry and other enterprises that rely on tourists directly or indirectly for all or part of their business.

The mission of the tourism council is "to promote and support the development of the visitor industry while preserving and enhancing the special character of the city and surrounding area." Barros has worked in various facets of the tourism industry and media, including experience in airlines, tour and charter companies, retail and international operations.

He has been a resident of San Antonio since the pre-opening of Rivercenter Mall in 1987. He developed the Grand Opening and marketing plans for this successful downtown center. In addition to opening Shopping Centers for Melvin Simon & Associates and The DeBartolo family, he created a grand opening team concept that was used in several cities in the country after successful openings and anniversaries in El Paso (Cielo Vista Mall), Harlingen (Valle Vista Mall), McAllen (La Plaza Mall), San Antonio (Rivercenter Mall) and New Orleans (New Orleans Centre).

He spent three years working for American Airlines as a sales consultant developing new marketing programs for several new routes. He created tour packages for Gray Line Tours of San Antonio and successfully exceeded over \$2 million in charter sales for the transit company.

He has traveled extensively in Latin America from Chile to Mexico assisting various businesses to set up operations and conducting research on new ventures. He set up Mexico Express in Monterrey, Mexico for the San Antonio Express-News, a direct marketing program to deliver catalogues to affluent homes in Mexico. Barros has conducted research in Argentina, Brazil, Panama, Chile and Mexico.

Marco, a native of Chile attended the Catholic University in Santiago in foreign languages and the University of Texas at El Paso where he obtained a Bachelor's Degree in Journalism. He continued his education at UT El Paso taking (MBA) business courses such as marketing, international business, finance, accounting and economics.

Barros is active in the Texas Travel Industry Association (TTIA) and the Airport Advisory Board for San Antonio International Airport. He is a member of the San Antonio Chamber of Commerce and active with the San Antonio Hispanic Chamber of Commerce.

In 2007, he was named by County Judge Nelson Wolff, Chair for Amateur Sports Committee for Bexar County to review various county proposals to build 13 new sports venues. This election passed with an overwhelming approval of 74% of the voters.

He is often invited to speak to Convention Bureaus, Chambers of Commerce and economic development groups on the impact of the tourism industry in communities and how to best use the Hotel Motel Tax. Past presentations have included the Corpus Christi Hotel Association, Rockport/Port Aransas Counties, the Austin CVB, the Rio Grande Valley Chambers as well as the Monterrey (Mexico) CVB and Monroe/Detroit communities with National Parks Service and the Warsaw Destination Alliance and Hotel Association (Poland). In 2011, he was the feature speaker in Monterrey, Mexico for a new Economic Development Organization and in 2012 he was also invited by the Governor of Zacatecas to speak on Tourism Development to his Economic Team in Zacatecas, Mexico.

Barros was named Honorary Consul for the Government of Chile in 2013, a post to assist better business relations between Chile and Texas. In January of 2015, Barros was elected Chairman of the San Antonio Airport Advisory Commission that advises the City of San Antonio on aviation issues.

During 2014-2015, he assisted the efforts in getting a World Heritage designation for the San Antonio Missions. This effort was led by over 12 organizations including the San Antonio Conservation, The City of San Antonio, Bexar County, San Antonio River Authority and supported by lobbying efforts by the San Antonio Tourism Council and the National Parks Conservation Association.

Huffstutler says his interest in flying started when his father began taking him out to the airport at a young age. By the age of 16, he had received his private pilot's license while still in High School.

He later went on to attend Texas A&M University, where he decided to study architecture but his urge to fly couldn't be squelched. During the summer recess at A&M he would work on his advanced rating gaining his Commercial, Multi-engine and Instrument rating in 1979.

In 1979 and 1980 he served as co-pilot of former Texas Gov. Dolph Briscoe Jr. flying the Howard 500 executive transport. In 1981, Huffstutler was hired by United Airlines and trained as a flight crewmember which ended when the airline went on strike and Huffstutler elected to return to concentrate on his entrepreneurial desires.

Huffstutler and his father purchased the fixed-based operation (FBO) business in Uvalde in 1980. This business, Uvalde Flight Center, was an established provider of fuel and transient aircraft services at the Uvalde Garner Field Municipal Airport which would be the genesis of the growing aviation business portfolio in the future.

His strategy for growing the business over the next 30 years would be to buy companies with aircraft modification rights and similar services and absorb these technologies into his own businesses. Through this approach, Huffstutler assembled a portfolio of 8 distinct business entities organized the umbrella of The SkyWay Group – a vertically integrated group of products and services invested with the corporate business aviation segment.
