BEFORE ME, the undersigned authority, on this day personally appeared the undersigned Affiant, known to me to be a credible person, and being by me first duly sworn, on oath deposes and says as follows:

"I am Manager of Boulders Mosaic, LLC, a Texas limited liability company (the "Company") which was organized on May 29, 2014. The Company was organized for the sole purpose of acquiring certain real property (the "Land") more particularly described in the Special Warranty Deed dated June 4, 2014 from Texas Community Bank to the Company recorded in Volume 16710, Page 2186, Official Public Records of Bexar County, Texas. The Land was purchased by means of a tax-deferred exchange pursuant to Section 1031 of the Internal Revenue Code, and more specifically, the Company was organized to act as an Exchange Accommodation Trustee pursuant to such law.

In connection with such transaction, at the time of the Company's formation First American Title Exchange Company owned one hundred percent (100%) of the membership interests of the Company, and its employee Mark Bullock was elected the Sole Manager of the Company.

On November 17, 2014, First American Title Exchange Company assigned all of its membership interests in the Company to Fair Oaks Mosaic TBY, LLC pursuant to instrument attached as Exhibit "A" to this Affidavit. Record title to the Land remained in the Company's name.

First American Title Exchange Company acted solely as an intermediary pursuant to Section 1031 of the Internal Revenue Code and has never had any beneficial ownership interest in the Land.

First American Title Company, an affiliate of First American Title Exchange Company, likewise has never had any beneficial interest in the Land and acted solely as title insurer and escrow agent in the Company's acquisition of the Land.

The Managers of the Company are Thomas Yantis and Blake Yantis and each is authorized to act on behalf of the Company. This Affidavit may be used for the purpose of evidencing such authority."




