## AN ORDINANCE

AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$1,058,213.10: (A) LSST MEDIA LLC DBA LONE STAR MEDIA FOR VEHICLE DECALS, (B) SANKEY EQUIPMENT COMPANY, INC., AND GENUINE PARTS COMPANY FOR SHOP TOOLS, PARTS AND SERVICE, (C) SCHINDLER ELEVATOR CORP. FOR AMENDMENT TO ANNUAL CONTRACT FOR ELEVATOR AND ESCALATOR MAINTENANCE FOR THE SAN ANTONIO AIRPORT SYSTEM, AND (D) CCG SYSTEMS, INC. DBA FASTER ASSET SOLUTIONS FOR AMENDMENT TO ANNUAL CONTRACT FOR FASTER FLEET FIRE ANNUAL SUPPORT.

WHEREAS, these bids and amendments are from the following companies to furnish the City with: (A) LSST Media LLC dba Lone Star Media for vehicle decals, (B) Sankey Equipment Company, Inc., and Genuine Parts Company for shop tools, parts and service, (C) Schindler Elevator Corp. for amendment to annual contract for elevator and escalator maintenance for the San Antonio Airport System, and (D) CCG Systems, Inc. dba Faster Asset Solutions for amendment to annual contract for Faster Fleet Fire annual support; and

**WHEREAS**, the bids submitted by SAT Radio Communications LTD dba Industrial Communications and Toronto Digital Imaging Inc. failed to meet the City's specifications and/or requirements for vehicle decals; and

**WHEREAS**, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(3), which provides for a procurement necessary because of unforeseen damage to public machinery, equipment, or other property, and 252.022(a)(7), which provides for a procurement of items that are available from only one source; and

**WHEREAS,** this ordinance approves one low qualifying bid contract, two low bid contracts, one amendment to increase the estimated annual expenditures pursuant to the unforeseen damage to public machinery, equipment, or other property exemption, and one amendment to extend the contract on the basis of sole source; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:
