2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The Aviation Department currently has Multi-Use Flight Information Display System (MUFIDS) components in both Terminal A and B that provides arrival/departure and gate baggage information that serves the airport, airlines, aircraft, and passengers at San Antonio International Airport. MUFIDS is made up of monitors, PCs, mounting hardware, programming, software and data feeds from the airlines. MUFIDS data availability and system operational readiness is critical to airport operations and customer service. The Aviation Department seeks to issue a Request for Offer (RFO) to Infax on the basis of a sole source exemption due to the proprietary nature of the Flight Information Display software, WinFids, utilized by the MUFIDS. Estimated annual costs are \$70,000.00 with a total contract value of \$350,000.00 for three years and two 1 yr, renewals.

Because the exemption stated above exists, the City of San Antonio intends to/contract with **INFAX** Incorporated which will cost approximate 4 350,000 (5yrs
