**SUMMARY:**

The Economic and Human Development City Council Committee will review and recommend applicants for ten available slots to the Airport Advisory Commission. The terms have expired for the following categories: one (1) Airport Business Lessee; one (1) Aviation Industry; two (2) Business Community; three (3) Community; one (1) Federal Aviation Administration (FAA); one (1) Taxi Cab Industry; and one (1) Travel and Tourism. The terms of office are for the remainder of unexpired terms of office to expire March 18, 2018. The term of office for the Business Lessee is for the remainder of an unexpired term of office to expire May 18, 2017. The applicants listed below qualify for appointment. Applicants who are not residents of the City of San Antonio will require a waiver for appointment.
