AN ORDINANCE

ALLOCATING \$61,000.00 IN TEXAS COMMISSION ON THE ARTS (TCA) FUNDS AND AUTHORIZING THE EXECUTION OF EIGHT CONTRACTS FOR FISCAL YEAR 2016 AND SIX CONTRACTS FOR FISCAL YEAR 2017, SUBJECT TO THE GRANT RECEIPT AND ACCEPTANCE OF FUNDS FROM THE TCA.

WHEREAS, the Department for Culture and Creative Development ("DCCD") regularly applies to the Texas Commission on the Arts ("TCA") for funding that helps leverage the City's local arts investment and through this process, DCCD was awarded funding to support local non-profit arts and cultural organizations; and

WHEREAS, the stART Place application process was created to award funding to arts organizations, neighborhood associations, and local artists/artists collectives to support creative projects that provide meaningful community enrichment and neighborhood transformation; and

WHEREAS, the Cultural Arts Board approved preliminary and final funding recommendations for stART Place on June 4, 2016 and June 7, 2016, respectively, which recommendations are reflected in Section 2, below; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A total of \$61,000.00 in TCA funds are awarded to the applicants listed in Section 2 in the amounts indicated. The terms and conditions of the template Arts Agency Contract for stART Place projects are authorized and approved and the City Manager, or her designee, is authorized to execute similar agreements with the agencies receiving such funding. A copy of the template Agreement is attached to this Ordinance as **Exhibit I**.

SECTION 2. For Fiscal Year 2016, the sum of \$30,500.00 has been appropriated in internal order 128000000027 and payment is authorized to the below individuals upon issuance of a Purchase Order. For Fiscal Year 2017, funding for the six contracts is subject to the award and acceptance of funding from TCA, upon which a new Internal Order and Fund will be created.

The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
