AUTHORIZING THE APPLICATION AND ACCEPTANCE OF A GRANT NOT TO EXCEED \$3,192.00 FROM THE TEXAS HISTORICAL COMMISSION TO REIMBURSE TRAVEL EXPENSES FOR UP TO THREE OFFICE OF HISTORIC PRESERVATION STAFF MEMBERS TO ATTEND THE 'FORUM' CONFERENCE OF THE NATIONAL ALLIANCE OF PRESERVATION COMMISSIONS IN MOBILE, ALABAMA FROM JULY 27 - 31, 2016.

WHEREAS, the Texas Historical Commission offers stipends to reimburse travel expenses for Certified Local Government representatives to attend the National Alliance of Preservation Commissions' 'FORUM' Conference; and

WHEREAS, the City of San Antonio is a Certified Local Government as that term is defined by the Texas Historical Commission and the National Historic Preservation Act; and

WHEREAS, the National Alliance of Preservation Commissions' 'FORUM' Conference is intended to provide valuable training related to preservation commissions and preservation staff; and

WHEREAS, Office of Historic Preservation staff are both preservation staff and support staff for the city's preservation commission, the Historic and Design Review Commission; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1 The City Manager, or her designee, or the Historic Preservation Officer, or her designee, is hereby authorized to apply for and accept grant funds in an amount not to exceed \$3,192.00 from the Texas Historical Commission to reimburse travel expenses for up to three Office of Historic Preservation staff members to attend the 'FORUM' conference of the National Alliance of Preservation Commissions in Mobile, Alabama from July 27 - 31, 2016

SECTION 2. Upon acceptance of this award, expenses paid up front from the Department's Preservation Academy fund will be reimbursed to the Department with monies received from Texas Historical Commission. Funds generated by this ordinance shall be appropriated in SAP Fund 29651000, Internal Order 22900000028 per the table below:

The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
