AN ORDINANCE

**ACCEPTING THE OFFER FROM FACILITY SOLUTIONS GROUP, INC.
DBA FSG LIGHTING TO PROVIDE AND INSTALL LIGHTING POLES
AND INSTALL LED FIXTURES AT KELLY AREA AND VIDAURRI
PARKS FOR THE CITY'S PARKS AND RECREATION DEPARTMENT
FOR A TOTAL COST OF \$164,844.24, FUNDED FROM THE FY2016
BUDGET AMENDMENT FOR DISTRICT 5 PARK IMPROVEMENTS.**

WHEREAS, an offer was submitted by Facility Solutions Group, Inc. dba FSG Lighting, through the Texas Local Government Purchasing Cooperative (a.k.a. the "Buyboard"), to provide and install steel light poles and install City furnished LED fixtures for a total cost of \$164,844.24; and

WHEREAS, this purchase meets the requirements under the terms of the Texas Local Government Purchasing Cooperative agreement adopted by the City of San Antonio by Ordinance No. 97097 on January 30, 2003; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer from Facility Solutions Group, Inc. dba FSG Lighting to provide and install steel light poles and install City furnished LED fixtures for a total cost of \$164,844.24 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Payment in the amount of \$164,844.24 in SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 26-00650, Park Improvements in District 5, is authorized to be encumbered and made payable to Facility Solutions Group, Inc. dba FSG Lighting.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
