## AN ORDINANCE

**AUTHORIZING EIGHT SERVICE PROVIDER** AGREEMENTS IN A CUMULATIVE AMOUNT OF \$1,504,760.00 RELATED TO THE 2016-2017 CITY OF SAN ANTONIO EARLY HEAD START - CHILD CARE PARTNERSHIP PROGRAM, ASSOCIATED **AMENDMENTS AND MEMORANDA** OF **UNDERSTANDING: AND AUTHORIZING** AN THE 2015-2016 **AMENDMENT** TO **FUNDING** APPLICATION TO REDUCE THE CITY'S IN-KIND MATCH.

WHEREAS, the federal Early Head Start – Child Care Partnership (EHS-CCP) program provides early education, family support, and support services to children between the ages of six weeks and five years, and their families, at or below the Federal Poverty Level, and prioritizes enrollment for those that are disabled, homeless, or in the foster care system and

WHEREAS, the City has served as an EHS-CCP grantee for 216 children since February 1, 2015 and, on April 28, 2016, through Ordinance 2016-04-28-0300, City Council authorized the submission of a continuation grant application and acceptance of \$2,656,800.00 for the period August 1, 2016 to July 31, 2017; and

WHEREAS, as the program grantee, DHS provides direct program management, oversight, technical assistance, governance, family support, and mental wellness services, and contracts with six child care centers for the provision of education services; the San Antonio Metropolitan Health District for dental services; and University Health system for health services; and

**WHEREAS**, awarded grant funds for the 2016-2017 Program Year will provide for the continuation of these services; **NOW THERFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1**. The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is hereby authorized to (1) execute eight service provider agreements, attached hereto and incorporated herein for all purposes as **Attachments I-VIII**, in a cumulative amount of \$1,504,760.00 related to the 2016-2017 City of San Antonio Early Head Start – Child Care Partnership (EHS-CCP) Program and (2) amend the City's 2015-16 EHS-CCP Funding Application to reduce the City's cash match.

**SECTION 2.** The City Manager or her designee, or the Director of the DHS or her designee, is further authorized to negotiate and execute, after review and approval by the City Attorney's Office, (1) contract amendments based on program improvements or additional awards and (2) memoranda of understanding with community organizations to collaborate regarding EHS-CCP services.

**SECTION 3.** So long as the City's portion of the required match is available in the City's budget, acceptance of additional EHS-CCP funds if awarded by the U.S. Department of Health and Human Services, any and all actions necessary to effectuate the acceptance, and provision of the City's match are hereby authorized.

**SECTION 4. Section 2.** Funds will be appropriated annually by fiscal year. The sum of \$1,504,760.00 is hereby appropriated in fund 2602238018. Payment is authorized per the table below upon issuance of a Purchase Order.
