APPOINTING MARK T. HUFFSTUTLER (AIRPORT BUSINESS LESSEE) FOR THE REMAINDER OF AN UNEXPIRED TERM OF OFFICE TO EXPIRE MARCH 18, 2017; APPOINTING ALEXANDER REIDEL (AVIATION INDUSTRY), DEBORAH A. OMOWALE (COMMUNITY); REAPPOINTING MARK R. FESSLER (BUSINESS COMMUNITY), GEORGE C. MEKETA (BUSINESS COMMUNITY), LESLIE A. HOBGOOD (COMMUNITY), MAUREEN M. MCCANN (COMMUNITY), EARL JACKSON, JR. (FEDERAL AVIATION ADMINISTRATION), GEORGE ALVA (TAXICAB INDUSTRY), AND MARCO BARROS (TRAVEL & TOURISM) TO THE AIRPORT ADVISORY COMMISSION FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MARCH 18, 2018; AND WAIVING THE CITY CODE RESIDENCY REQUIREMENT IN CHAPTER 2, ARTICLE IX, SEC. 2-529(B) FOR MARK T. HUFFSTUTLER, ALEXANDER REIDEL, AND GEORGE C. MEKETA FOR THIS APPOINTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. Mark T. Huffstutler (Airport Business Lessee) is appointed for the remainder of an unexpired term of office to expire March 18, 2017.

SECTION 2. Alexander Reidel (Aviation Industry) and Deborah A. Omowale (Community) are appointed; and Mark R. Fessler (Business Community), George C. Meketa (Business Community), Leslie A. Hobgood (Community), Maureen M. McCann (Community), Earl Jackson, Jr. (Federal Aviation Administration), George Alva (Taxicab Industry), and Marco Barros (Travel & Tourism) are reappointed to the Airport Advisory Commission for the remainder of unexpired terms of office to expire March 18, 2018.


