## AN ORDINANCE 2016-06-16-0484

AUTHORIZING THE STREET NAME CHANGE OF "VAN BUREN LANE" TO "PAPE FARMS LANE" BETWEEN THE CROSS STREETS OF WOODBURY DRIVE AND WORLDLAND ROAD IN CITY COUNCIL DISTRICT 10, SAN ANTONIO, TEXAS.

WHEREAS, the Development Services Department received a request to rename Van Buren Lane between Woodbury Drive and Worldland Road as "Pape Farms Lane" to recognize the Pape family for their contribution of agricultural production in the San Antonio area and as part of a broader effort to associate the street name with its location, area characteristics and history; and

WHEREAS, staff began implementing this request through the street renaming process as required by Chapter 6 of the City Code; and

WHEREAS, staff forwarded the request to all City of San Antonio departments and outside agencies for review and acquiescence and no opposition has been identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for street renaming; and

WHEREAS, staff properly posted and mailed notice of this request to attach the street renaming to said street to abutting property owners and notice requirements for renaming of the street have been satisfied in accordance with Chapter 6 of the City Code with no written oppositions received to the name change from abutting property owners; and

WHEREAS, the Planning Commission held a public hearing on June 8, 2016 allowing all interested persons to be heard, discussed and recommended approval to renaming the street. NOW THEREFORE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** "Van Buren Lane" located in City Council District 10 between between Woodbury Drive and Worldland Road is hereby renamed "Pape Farms Lane." All naming requirements of Chapter 6 of the City Code have been met, or are hereby waived. The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect.

**SECTION 2.** Funds generated by this ordinance for application and notification fees will be deposited into Fund 29097000, Internal Order 229000000000 and General Ledger 4406775.

**SECTION 3.** Funds generated by this ordinance for street sign manufacturing and installation fees will be deposited into Fund 11001000, Internal Order 223000000158 and General Ledger 6301120.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5**. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.
