

AN ORDINANCE

AWARDING A CITY COUNCIL PROJECT FUND GRANT ALLOCATION TO THE NORTH EAST INDEPENDENT SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$42,000.00 FOR THE DISTRICT 9 SCHOOL ZONE SAFETY PROGRAM, AS REQUESTED BY CITY COUNCIL MEMBER JOE KRIER, DISTRICT 9.

WHEREAS, the adopted FY 2016 budget provides for individual City Council district discretionary funds, referred to as City Council Project Funds for programs, activities, events, scholarships, goods, or services that promote specified municipal public purposes set out in guidelines approved by City Council pursuant to Ordinance 2011-12-08-1011 dated December 8, 2011 and updated pursuant to Ordinance 2013-11-07-0761; and

WHEREAS, City Council member Joe Krier has submitted a request for CCPF in the amount of \$42,000.00 for the District 9 School Zone Safety Program, for the purchase of safety vests, patrol belts, flashers, safety cones, and hand-held stop signs, to help reduce the number of pedestrian accidents in school zones in the North East Independent School District; and

WHEREAS, the School Zone Safety Program raises awareness through educating elementary and middle school students on school zone safety, and will benefit an estimated ten thousand students in thirteen elementary and five middle NEISD schools in District 9; and

WHEREAS, this initiative meets the objectives set out in the CCPF Guidelines and it is the desire of City Council to support and approve this request; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Funding in the amount not to exceed \$42,000.00 for this ordinance is available in Fund 11001000, Cost Center 0109050001 and General Ledger 5201040, as part of the Fiscal Year 2016 Budget.

SECTION 2. Payment not to exceed the budgeted amount is authorized, and shall be encumbered with a purchase order upon the selection of vendors by the City following a formal bid process.



The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

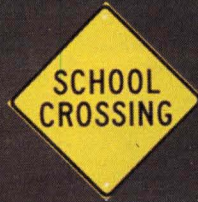
