The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call and noted the following Councilmembers present:

Councilmember Nirenberg highlighted the project and asked for a brief presentation. Razi Hosseini provided a map of the project area and rendering of the pedestrian crossing. He spoke of the project benefits to include contributing to the Vision Zero Plan by providing safer crossing conditions for pedestrians. He noted the elevation view of the HAWK System and mentioned that the project was scheduled for completion in October. Councilmember Nirenberg stated that the issue had been brought to attention by Medical Center Employees due to various tragic pedestrian and traffic accidents over the last three years. He recognized the UT Health Science Center and Medical Center Alliance for their contributions.

Councilmember Viagran asked if other areas had been identified for new HAWK Systems. Mr. Hosseini replied that the Master Plan for the Medical Center included two other areas for Pedestrian Improvements but was not sure if they would include HAWK Systems.

Councilmember Viagran asked who performed the study to identify if a HAWK System was warranted. Mike Frisbie stated that TCI Traffic Engineers performed the study which was based on the number of pedestrians and vehicles. Councilmember Viagran stated that there was a site in District 3 that they were reviewing and thanked everyone for their work.

Councilmember Gonzales asked of the project cost. Mr. Hosseini replied that the project included sidewalks and landscaping in addition to the signal. He stated that the Medical Center had their own design criteria to include a Double Bar Traffic Signal which was more expensive than the regular HAWK System.

Councilmember Medina expressed his support and noted the importance of public safety. He noted concerns at Culebra and Mira Vista Streets and stated that he would like staff to work on a plan for same.

Councilmember Nirenberg moved to adopt the proposed Ordinances for Items 10A and 10B. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

Councilmember Saldaña highlighted the Federal Funding and asked how the projects were targeted. Anthony Chukwudolue stated that they were targeted through ReNew SA encompassing seven areas throughout the city. Councilmember Saldaña spoke to the city's commitment to Sidewalks and Infrastructure and asked of assistance from the State with regard to streets and neighborhoods. Mike Frisbie replied that the Texas Department of Transportation (TxDOT) was a great partner that focused on TxDOT Roadways such as Highways and Arterials.

Councilmember Treviño spoke of the importance of the projects and asked if there were specific construction methodology requirements. Mr. Frisbie replied that they utilize specific design criteria and construction management similar to what TxDOT uses. Councilmember Treviño expressed support for utilizing innovative construction methodology in future projects.

Councilmember Lopez referenced the TxDOT Takeback Program and asked staff to look at the potential to fund curbs and sidewalks when taking back streets through said program.

Councilmember Saldaña moved to adopt the proposed Ordinances for Items 11A and 11B. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Treviño highlighted the project and asked for a brief overview. Razi Hosseini explained that the project would help alleviate flooding issues and reduce the amount of time that the street is closed when significant rainfall occurs. He stated that they worked with TxDOT to pump the water through an underground system. He added that the

temporary easement would only be utilized throughout the duration of the project.

Councilmember Treviño moved that the City of San Antonio authorize the use of the power of eminent domain to acquire property for a public use project for the McCullough Avenue Area Drainage Project by acquiring the following property described by the City Clerk and incorporated as part of this Motion. Councilmember Viagran seconded the motion.

City Clerk Vacek read the property description: The properties consist of temporary construction easements totaling 0.040 acres out of two parcels of real property located in New City Block 1002 and 1003, Real Property Records of Bexar County, Texas. These properties are depicted in the Project Map marked as Exhibit A and more particularly described by metes and bounds in Exhibits B and C attached to the Ordinance and incorporated as part of this Motion.

13. An Ordinance authorizing an amendment to a Texas Department of Transportation agreement that will increase the available area under IH37 for use by the City as parking lots. [Lori Houston, Assistant City Manager; John Jacks, Interim Director, Center City Development & Operations Department]

Councilmember Warrick requested a brief presentation. John Jacks stated that the city had an agreement with TxDOT that allows the city to use property under IH-37 for a parking lot. He noted that the amendment would allow the city to expand the agreement to include property located at the corner of 9th and Austin Streets. He stated that it would include 175 Spaces, 2 Pay Stations, LED Security Lighting, and Landscaping. Councilmember Warrick asked how long it would take to get additional parking added to the agreement. Mr. Jacks replied that he was unsure and that the current amendment had taken time due to ensuring there was agreement from the surrounding area.

Councilmember Warrick moved to adopt the proposed Ordinance for Item 13. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

An Ordinance authorizing the submission of a grant application to the Centers for Disease Control and Prevention and the acceptance of funds in an amount up to \$1,625,000.00 for a grant on preventing teen dating violence and youth violence for a five year term. [Erik Walsh, Deputy City Manager; Vincent R. Nathan, PhD, MPH, Interim Health Director]

Councilmember Warrick asked of the duties of the three staff that would be funded through the grant. Dr. Vincent Nathan responded that the three positions would work with Schools, Stand Up SA, and develop the curriculum for Violence Prevention. Councilmember Warrick asked how critical the issue was in the area. Dr. Nathan replied that the second leading cause of death among youth ages 10 to 24 was violence and that Bexar County had a higher rate than the State and United States Average. Councilmember Warrick requested that staff provide the curriculum at community centers and neighborhoods in addition to the schools.

Councilmember Gonzales asked if this was a new concept. Dr. Nathan confirmed that it was and stated that they were hoping to prevent violence at a younger age before it leads to Adult Violence. Councilmember Gonzales if there was other funding available to address the issue. Dr. Nathan stated that they were looking at all forms of grants.

Councilmember Viagran stated that this was a very important issue to address and highlighted the statistics in the State and Bexar County. She asked if staff currently visited schools to discuss Teen Dating Violence. Deputy Chief Anthony Treviño confirmed that Police Officers visit schools and stated that February is Teen Dating Violence Awareness Month. He mentioned that they conduct a Social Media Campaign in coordination with the Health Department to increase awareness. Councilmember Viagran requested performance measures when available.

Councilmember Warrick moved to adopt the Ordinance. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 17:

17. An Ordinance authorizing the submission of a grant application and acceptance of funds upon award in an amount up to \$5,417,604.77 to the U.S. Department of Transportation for the Nationally Significant Freight and Highway Projects FASTLANE16 Grant for the design of the Zarzamora Street at Frio City Road Railroad Overpass in Council District 5. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Mike Frisbie presented information regarding the FASTLANE 16 Grant noting that the City of San Antonio had submitted a Technical Application for Zarzamora Street at Frio City Road Railroad Overpass in District 5. He stated that the project was located in the Zarzamora Corridor on the West Side of San Antonio's Urban Core in proximity of Port He noted that the Union Pacific Railroad Track crosses the intersection along Zarzamora Street and causes significant traffic delays due to having 30 trains within a He highlighted project benefits to include pedestrian and bicycle safety intersection improvements, and vehicular movements removed from the rail crossing. indicated that the FASTLANE 16 Grant would provide 60% of the funding for the project totaling \$5,417,605 and the City of San Antonio would provide 40% totaling \$3,611,737. Councilmember Gonzales stated that they had made some improvements to the intersection to improve traffic flow to include reducing one lane of the intersection. She mentioned that she was disappointed that said project did not receive MPO Funding and asked of the probability of future MPO Funding. Mr. Frisbie noted that said project was placed in Category B by the MPO for future consideration. He stated that this was a high priority for the 2017 Bond Program and felt strongly that it would be funded by the MPO.

Councilmember Lopez stated that the lack of funding for this project was similar to the New Braunfels Avenue Extension through Brooks City Base. He noted that they were placed on the Category B List by the MPO to identify funding for development. Mr. Frisbie stated that both projects were looking for grant funding and that this project on Zarzamora qualified for said grant due to the heavy freight rail going through it. He spoke of the process for funding projects at the MPO which followed a five-year plan and noted that there would be another call for projects in two years.

Councilmember Nirenberg asked of the amount of the At-Grade Rail Crossings in the city. Mr. Frisbie stated that he did not have that information and would provide it to the City Council. Councilmember Nirenberg spoke of the traffic-related and safety issues and stated

that he would like to discuss potential solutions.

Councilmember Krier asked of the role of Union Pacific. Mr. Frisbie stated that they worked with them to automate the track system and were working on eliminating At-Grade Crossings.

Councilmember Saldaña expressed his support and stated that this intersection was one of the worst in the city. He stated that this was a step in the right direction.

Councilmember Gonzales moved to adopt the proposed Ordinance for Item 17. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

An Ordinance authorizing the issuance of one or more series of not to exceed \$609,035,000 "City of San Antonio, Texas Electric and Gas Systems Revenue Refunding Bonds, New Series", as further distinguished by series in the event of multiple issuances; providing the terms, conditions, and specifications for such Bonds, including the approval and distribution of an official statement pertaining thereto; making provisions for the payment and security thereof on a parity with certain currently outstanding obligations; stipulating the terms and conditions for the issuance of additional revenue bonds on a parity therewith; authorizing the execution of one or more paying agent/registrar agreements, escrow and trust agreements, and bond purchase agreements; complying with the requirements of the depository trust company; delegating the authority to certain members of the City Public Service Board staff to execute certain documents relating to the sale of the Bonds; enacting other provisions incident and related to the subject and purpose of this Ordinance; and providing an effective date. [Ben Gorzell, Chief Financial Officer; Troy Elliott, Director, Finance]

Councilmember Saldaña asked if CPS Energy utilized the same Minority-Owned Goals when hiring Underwriting Firms. Ben Gorzell asked Gary Gold to answer the question on behalf of CPS Energy. Mr. Gold stated that they utilized a Pool of Underwriters that includes a number of Large Firms and also some Local Minority Firms. He noted that they release a Request for Proposals every five years to refresh their Underwriting Pool and rotate firms based on transactions.

Councilmember Saldaña moved to adopt the proposed Ordinance for Item 23. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

24. An Ordinance authorizing CPS Energy LED rates for five new streetlight rate classes as well as updated prices on the existing LED Retrofit streetlight tariff. [Ben Gorzell, Chief Financial Officer; Troy Elliott, Finance Director]

Councilmember Treviño highlighted said item noting the importance of migrating to two technologies that were better and provided a cost savings over time. However, he stated that the Downtown Area needed a well thought-out solution and asked staff for a brief Ben Gorzell presented information comparing Light-Emitting Diodes (LEDs) presentation. He highlighted the benefits of LEDs to include reduced to High-Pressure Sodium (HPS). He outlined the City Streetlight Inventory Retrofit Plan energy usage and fuel costs. totaling 72,500 Street Lights City-Wide. He mentioned that the LED Retrofit Rate was approved by the City Council in 2012 with 1,500 lights in the Downtown Area being retrofitted by October 2016. He stated that the Proposed Ordinance would provide for LED Rates for 5 New Streetlight Rate Classes and Updated Prices on the Existing LED Retrofit He noted that Residential Streetlight Improvements would net \$867,000 Streetlight Tariff. in savings over 17 years. He highlighted LED Technology Considerations that would provide real time outage monitoring, dimming capability, and consumption monitoring.

Councilmember Treviño stated that they should take a hard look at lighting systems throughout the city and asked of other systems available. Mr. Gorzell replied that there were other technologies that were evolving. Councilmember Treviño expressed concern with the amount of lumens in the Downtown Area and stated that he would like the opportunity to modify the design.

Councilmember Viagran asked of the tariff, specifically what were the rates being recommended for approval. Mr. Gorzell replied that the rates being recommended would cost less for LEDs compared to the current HPS Lights. Councilmember Viagran asked if this was the most efficient and up-to-date technology. Mr. Frank Almaraz of CPS Energy stated that it was and that they continued to look for new technologies. Councilmember Viagran stated that she was pleased with the additional lighting for residential streets.

Councilmember Gonzales confirmed that there was not a rate increase for customers. Mr.

Gorzell stated that there was not a rate increase for customers. Councilmember Gonzales stated that she was pleased with the additional lighting provided in District 5 and asked of the life cycle. Mr. Gorzell replied that the average life cycle was 15 to 20 years.

Councilmember Lopez stated that he had attended a Smart City Conference in February which showcased lighting options in various cities. He noted the technology related to Shot Spotter and mentioned that there was more dialogue that needed to occur regarding other technologies for the future.

Councilmember Treviño moved to adopt the proposed Ordinance for Item 24. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Treviño recognized Tony Piazzi of Centro San Mr. Piazzi stated that this was a great investment that would leverage previous investments made in the Broadway Cultural Corridor. He thanked the Midtown TIRZ #31 Board for their financial support. Councilmember Trevino noted that this is great effort and highlighted the interest in this project which would provide a model for the city to use in other areas.

Councilmember Warrick asked how mass transit would be factored into the Traffic Study. Mr. Piazzi replied that the organization conducting the Study would look at existing conditions as well as those out to Year 2040. He stated that this would help to form the conceptual design and was very early in the process. Councilmember Warrick stated that

 - B. Tree City USA Recognition

A. Mrs. Sculley announced that the American Heart Association had awarded the San Antonio Fire Department with the 2016 Mission Lifeline EMS Gold Level Recognition Award. She stated that Mission Lifeline was a coordinated effort between EMS and Hospitals to provide the most expedient and expert care to patients suffering from a Heart Attack. She noted that early recognition and intervention by EMS Providers allows them to effectively communicate ahead to the receiving hospital, saving valuable time and increasing the patient's odds of survival. She reported that the San Antonio Fire Department had embraced the concept by following the evidence-based guidelines set forth by the American Heart Association. She stated that this was the second year in a row that the Fire Department had received the prestigious commendation.

B. Mrs. Sculley reported that the City of San Antonio was one of more than 3,400 towns and cities across the nation to be recognized as a "Tree City USA." She stated that the Arbor Day Foundation's "Tree City USA" Program gives national recognition to efforts in establishing a healthy, sustainable, Urban Forestry Program. She noted that the city has a strong track record in maintaining the community's tree canopy. She mentioned that in 1997, the City Council created a Tree Preservation Team in conjunction with the first Tree Preservation Ordinance approved the same year. She stated that today, the City Arborist manages a staff of 13 under the Development Services Department. Additionally, the Development Services, Parks & Recreation, and TCI Department have an annual combined budget of \$3.4 Million dedicated to the preservation and maintenance of trees in the city. She stated that the investment includes Community Outreach Programs to raise public awareness of the value and benefits provided by a healthy and diverse Tree Canopy. She added that acceptance into the Tree City USA Program was a great opportunity to educate the community about the value and benefits provided by trees and the Tree Canopy.

Art Reinhardt, Assistant Director of TCI, presented an update of the heavy rainfall that has occurred throughout the city.

Catherine Hernandez presented Item Z-3 and stated that staff and the Zoning Commission recommended denial with an alternative recommendation for two dwelling units. She reported that of 38 notices mailed; two were returned in opposition and none in favor.

Mayor Taylor called upon the citizens registered to speak.

Ted Gonzales, Applicant, stated that he was depending on the funds for his retirement and was still working very hard at 79 years-old. He noted that he had met all of the requirements and did not understand the concerns.

Jorge Cruz stated that he was speaking in support of the request noting that Mr. Gonzales had followed all of the requirements. He noted that Mr. Gonzales was a hard worker and would like to be like him one day.

Evangelina Gonzales, Applicant, stated that she and her husband had constructed the duplex behind their home to assist them financially. She noted that there were other duplexes in the area and did not understand the concerns of the neighbors. She added that they had followed all of the proper procedures.

Frank Trevino stated that he was speaking on behalf of Mr. Timoteo Escobar in opposition to the request. He noted that it was a dead end street in which many elderly individuals lived. He expressed concern with the emergency vehicles that would have difficulty getting in and out of the area.

Charles Henry addressed the City Council in opposition to the request. He stated that his property abuts the property in question and he was concerned with the residents of the duplex that stay up late and mess with his dogs. He noted that his daughters did not feel safe in the home due to the renters.

Pearl Henry stated that she and her sister did not feel safe in their home due to the behavior of the renters. She expressed concern that one of the renters was speaking poorly of her and her family to another neighbor.

Councilmember Treviño stated that he appreciated the comments on the case and felt they had reached a good compromise.

Councilmember Treviño moved to approve staff's alternate recommendation for a total of two units. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Catherine Hernandez presented Item Z-13 and stated that staff and the Zoning Commission recommended approval. She reported that of 31 notices mailed; two were returned in opposition and none in favor. She added that the Vance Jackson Neighborhood Association was in support of the request.

Mayor Taylor called upon the citizens registered to speak.

Patricia Seidenberger addressed the City Council in opposition to the request. She stated that she and her husband had lived in Mission Trace since 1974 and they were concerned with the traffic congestion in the area. She noted that Mission Trace had one entrance, one exit, no sidewalks and was concerned with safety for the children in nearby schools.

Joan Gaither stated that she was a new homeowner in Mission Trace and opposed to the request. She noted concern with safety for the children in nearby schools and added that pocket parks would better serve the area.

Karen Vaught stated that she had lived in Mission Trace since 1955. She noted that she was not opposed to development but concerned with the process. She indicated that the report provided at the Zoning Commission had many errors and that notification did not meet the requirements.

June Kachtik stated that she resided at Rock Creek Run and was President of the Vance Jackson Neighborhood Association. She noted that their Board met with Daniel Ortiz, the Applicant's Representative and voted to approve the zoning request contingent upon Restrictive Covenants.

Daniel Ortiz addressed the City Council on behalf of the Applicant. He stated that the current zoning allows up to 11 acres per unit and allows for other uses. However, the proposed zoning would only add a PUD Overlay. He stated that by adding the PUD Overlay, they would decrease the maximum potential density to 7 units per acre. He added that they would maintain trees and historic elements on the property to include the main house and watch tower.

Bill Hurley stated that he lived in Mission Trace and was in support of the request. He asked that they consider pocket parks if possible.

Tommy Keck stated that he owned the adjacent two properties directly south of the proposed property. He noted that he was not completely opposed to the project but concerned with traffic and child safety.

Councilmember Nirenberg asked of the notification process. Mr. Rod Sanchez replied that they notified everyone within 200 feet of the zoning case as well as Registered Neighborhood Associations within that boundary. He stated that they had posted a sign on the property; however, there had been rain and hail storms that could have blown the sign away. Councilmember Nirenberg thanked the citizens that came to speak and stated that he understood their concerns. However, he noted that the developer had agreed to preserve Heritage Trees as well as Historic Elements on the property. He stated that they would be looking at conducting a traffic study and use any available tools to mitigate concerns. He provided a draft of the Restrictive Covenants for the record.

Councilmember Gonzales asked of the PUD. Ms. Hernandez stated that it was a Planned Unit Development. Councilmember Gonzales asked why a Traffic Impact Analysis was not required. Ms. Hernandez replied that it was not required because the peak hour trips were not reached with the proposed plan for 37 units.

Councilmember Gallagher asked if the trees that would be preserved met the requirements

of the city. Mr. Sanchez stated that this was currently a single family home and the Tree Ordinance was not applicable. Councilmember Krier expressed support and recognized Roy Barrera, Sr. who was in the audience.

Councilmember Nirenberg moved to approve Item Z-13 with an allowance for an 8-foot fence. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:
