### AN ORDINANCE 2016-08-04-0548

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN AN AMOUNT UP TO \$265,924.00 TO THE U.S. DEPARTMENT OF JUSTICE TO SUPPORT THE CHILD WELFARE STRATEGIC ALLIANCE PROGRAM; AND AUTHORIZING AN INTERLOCAL AGREEMENT WITH BEXAR COUNTY REGARDING DISTRIBUTION OF GRANT **FUNDS** AND THE DESIGNATION OF BEXAR COUNTY AS THE GRANT FISCAL AGENT.

WHEREAS, the U.S. Department of Justice (DOJ) has available as much as \$664,811.00 in 2015 Justice Assistance Grant funds to support the Child Welfare Strategic Alliance Program, a joint project of the City and Bexar County that addresses child abuse; and

WHEREAS, of the total grant award, the City would receive \$265,924.00; and

WHEREAS, a cash matching contribution of \$8,832.00 is required; and

WHEREAS, the grant period is October 1, 2015, to September 30, 2019; and

WHEREAS, it is necessary to authorize the submission of a grant application for said grant funds and to authorize the acceptance of said grant funds, if awarded; and

WHEREAS, it is also necessary to authorize the execution of an interlocal agreement with Bexar County which authorizes Bexar County to submit a grant application for the aforementioned grant, that designates Bexar County as the grant's fiscal agent, and that provides that Bexar County will conduct the administration of the grant funds; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager and her designee are hereby authorized to submit a joint grant application in a total amount not to exceed \$664,811.00, of which the City of San Antonio will receive an amount not to exceed \$265,924.00, to the DOJ for 2016 Justice Assistance Grant funds to support of the Child Welfare Strategic Alliance Program. The City Manager and her designee are also hereby authorized to accept said grant, if awarded under the same terms and

conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said application and acceptance.

**SECTION 2.** The City Manager and her designee are hereby authorized to execute an interlocal agreement with Bexar County that authorizes Bexar County to submit a 2016 Justice Assistance Grant application to the DOJ in support of the Child Welfare Strategic Alliance Program, that designates Bexar County as the grant's fiscal agent, and that provides that Bexar County will conduct the administration of the grant funds. A copy of said agreement is attached hereto as **Exhibit I**, and the terms of the agreement are hereby approved. Should the parties be unable to agree upon an agreement that is substantially the same as that attached, subsequent City Council action shall be required for authorization to execute the agreement.

**SECTION 3.** Fund 26028000 (Department of Justice) is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant. Should funding be awarded, the sum of up to \$265,924.00 from the DOJ will be appropriated in said fund. A proposed budget and personnel complement attached hereto as **Exhibit II** are hereby approved. Upon award of the grant, the City will contribute a cash match of up to \$8,832.00.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

§ INTERLOCAL AGREEMENT FOR 2016 BYRNE

JUSTICE ASSISTANCE GRANT PROGRAM

§ FUNDING OPPORTUNITY NUMBER CFDA #16.738

This interlocal agreement regarding the 2016 Byrne Justice Assistance Program ("JAG") award (the "Agreement") is entered between the County of Bexar, a political subdivision of the State of Texas ("COUNTY") and the City of San Antonio, a Texas home-rule municipal corporation ("CITY")(also, individually, the "Party" or, collectively, the "Parties"), pursuant to authority granted under the Interlocal Cooperation Act, Tex. Gov't Code Ann. §791.001, et seq.

#### RECITALS

- The Department of Justice ("DOJ") requires either CITY or COUNTY, but not both, to submit an application for the 2016 JAG award for which the Parties are eligible and to serve as fiscal agent for the funds.
- At CITY's request, COUNTY has agreed to serve as the applicant and fiscal agent for the funds.
- Each Party, in performing governmental functions or in paying for the performance of governmental functions under this Agreement, shall make the performance or payments from current revenues.
- Each Party finds that the performance of this Agreement is in the best interests of both Parties and that the undertaking will benefit the public.

# PURPOSE

1.01 The purpose of this Agreement is to establish the terms under which the Parties will apply for and expend the 2016 JAG award for which the Parties are eligible.

#### ARTICLE II TERM

2.01 This Agreement becomes effective when executed by all Parties and, except as otherwise provided, will expire when all obligations of the Parties under this Agreement have been performed or on September 30, 2019, whichever is earlier.

### ARTICLE III APPLICATION FOR FUNDS

- 3.01 COUNTY will apply for the 2016 JAG award on behalf of the Parties.
- 3.02 COUNTY will serve as fiscal agent for the JAG award.

## ARTICLE IV

- 4.01 The Parties have allocated between themselves the \$664,811.00 FY 2016 JAG award for which COUNTY will apply, taking into account the certification of the Office of the Texas Attorney General to the DOJ regarding the "disparate funding situations" in Bexar County, Texas.
- 4.02 CITY is allocated \$265,924.00 of the 2016 JAG award for projects identified in Exhibit A that prevent, reduce and control crime, improve public safety and better serve the efficient administration of justice, which funds must be expended no later than September 30, 2019. If CITY desires to reprogram funds allocated for a project identified in Exhibit A, it shall submit the proposed change to COUNTY's Auditor and its Department of Management and Finance (the "Department") for approval prior to expending funds on the change. The Auditor's and the Department's review of the proposed change must be completed within 10 days of receipt. If either the Auditor or the Department do not approve the proposed change, the matter will be resolved by a conference call among the Auditor, CITY's representative and DOJ. Requests for reprogramming by CITY must be received by the Auditor and the Department no later than six months before the expiration of the four-year term of the grant award. Any JAG funds not expended by the end of the term must be returned to COUNTY.
- 4.03 COUNTY is allocated \$398,887.00 of the 2016 JAG award for projects identified in Exhibit A that prevent, reduce and control crime, improve public safety and better serve the efficient administration of justice, which funds must be expended no later than September 30, 2019.
- 4.04 COUNTY will pay CITY that portion of the JAG award allocated to CITY under this Agreement within 15 days of receipt of the funds.
- 4.05 Each Party will place its allocation in a trust account. Any interest earned by that account must be spent in accordance with the requirements of the JAG program. If CITY desires to spend the interest on a project that is not identified in Exhibit A, the Parties will follow the process for reallocation of funds identified in Section 4.02 above.

## ARTICLE V COMPLIANCE WITH LAWS

5.02 Each Party warrants and represents that the expenditure of its allocation under the JAG Program for grant year 2016 will fully comply with all legal requirements for use of the funds and for the purposes specified in all applicable statutes, rules or regulations pertaining to the JAG Program, including but not limited to those expressly set out in this Agreement.

#### ARTICLE VI PROGRAM RECORDS AND REQUIREMENTS

- 6.01 CITY shall maintain all records relating to the receipt and disbursement of the 2016 JAG funds and all records that quantify or identify the performance of resources, activities, services or positions funded by the 2016 JAG funds until three years after all of those funds have been expended.
- 6.02 Upon giving reasonable notice, COUNTY's Auditor or her representative may review the

records maintained by CITY in accordance with Section 6.01 above.

### ARTICLE VII

- 7.01 Nothing in the performance of this Agreement will impose any liability for claims against either Party other than claims for which the Texas Tort Claims Act may impose liability.
- 7.02 Each Party will be responsible for its own actions in providing services under this Agreement.

# ARTICLE VIII TEXAS LAW TO APPLY

8.01 This Agreement will be construed under and in accordance with the laws of the State of Texas, and all obligations of the Parties under this Agreement are performable in Bexar County, Texas.

# ARTICLE IX LEGAL CONSTRUCTION

9.01 If any one or more of the provisions contained in this Agreement is for any reason held invalid, illegal or unenforceable in any respect, this Agreement will be construed as if the invalid, illegal, or unenforceable provision had never been contained in this Agreement.

# ARTICLE X ENTIRE AGREEMENT

- 10.01 This Agreement supersedes any and all agreements, either oral or in writing, between the Parties, with respect to the subject matter, and no other agreement, statement or promise relating to the subject matter of this Agreement will be valid.
- 10.02 This Agreement does not create any rights in any party not a signatory to this Agreement.

#### ARTICLE XI AMENDMENT

11.01 No amendment, modification, or alteration of the terms of this Agreement will be binding unless it is in writing, dated subsequent to the date if this Agreement and duly executed by the Parties.

# ARTICLE XII LIAISONS AND NOTICES

12.01 Bexar County employee, Audrey M. Cavazos and/or a representative from Bexar County Budget and Finance shall be COUNTY's designated representative responsible for the management of this Agreement unless CITY receives written notification to the contrary from COUNTY.

- 12.02 The City of San Antonio Police Department employee, Robert C. Looney and/or a representative from the San Antonio Police Department shall be CITY's designated representative responsible for management of this Agreement unless COUNTY receives written notification to the contrary from CITY.

# FY 2016 Justice Assistance Grant Bexar County and the City of San Antonio Disparate Jurisdiction I. Project Abstract

Applicant's Name: Bexar County, Texas

Title of the Project: FY 2016 Bexar County and City of San Antonio Justice Assistance Grant

Goals of the Project: The goals of the projects are to adhere to the U.S. Department of Justice grant rules and regulations for local law enforcement projects that range from problem solving courts, domestic violence programs, victim service programs, a correctional services program, and a multi-jurisdictional child enforcement task force. Major objectives are: lower drug/alcohol related recidivism rates; advocate for persons who have suffered domestic violence or elder fraud; and provide law enforcement investigations of children who have suffered domestic or sexual violence. A new funded project this fiscal year includes treatment/contractual costs for the Bexar County Esperanza Court (Prostitution Prevention Court) to provide pertinent substance abuse and/or mental health treatment services to the participants.

The majority of the projects have been in existence and funded by previous Bexar County and City of San Antonio Justice Assistance Grants. The strategies and coordination of the projects are successful and continue to operate with JAG funded staff that are trained.

Bexar County and the City of San Antonio will fund a combination of continuation projects that will serve the following types of project identifiers: adjudication, case management, corrections, court advocacy, crime prevention, substance abuse prevention, probation, problem-solving courts, violence – violent crimes, witness, and law enforcement.

A narrative of the projects and their budgets are attached.

# II. Bexar County FY 2016 Justice Assistance Grant (JAG) Program and Budget Narrative

1) Civil District Court Family Drug Court Sustainability Project

Allocation: \$76,654 (Salaries and Benefits)

Position Funded: One Family Court Monitor/Manager

Purpose Area: Drug Treatment and Enforcement Program

Continuation Project since 2010 JAG

The mission of the Bexar County Family Drug Court is to utilize the court and the community to empower parents to live drug-free and gain the skills necessary to care appropriately for their children. This program is intended to assist families that have been separated by the effects of drug and alcohol abuse. Families to be considered for the Family Drug Court are referred to the court by Child Protective Services (CPS), following the removal of children by CPS from their parents' care. This project is budgeted to fund the salaries and benefits of one Family Support Monitor/Manager for one fiscal year. The Family Support Monitor/Manager has routine contact with the participants of the Family Drug Court and acts as the court's case manager. The data tracked encompasses all participants and their activities in the program: drug treatment plan, judicial supervision, drug testing, case management and program evaluation.

2) Judicial Services Adult Drug Court Sustainability Project (Misdemeanor)

Allocation: \$59,061 (Salaries and Benefits)

Position Funded: One Adult Probation Officer

Purpose Area: Drug Treatment and Enforcement Program - Prosecution

and Courts

Continuation Project since 2009 Recovery Act JAG (ARRA)

The Bexar County Adult Criminal Drug Court is a post-adjudication program which serves as an alternative to jail and prison. This court is modeled after the Ten Key Components as articulated by the Bureau of Justice Assistance (BJA) and the National Association of Drug Court Professional (NADCP). This project will fund salaries and benefits for one adult probation officer for the misdemeanor adult drug court. The adult probation officer will be responsible for preparing monthly Personnel Activity Reports to satisfy grant documentation regulations. The adult probation officer's duties entail having routine contact with the participants of the drug courts and monitoring the terms and conditions of the drug court enrollment process: drug treatment and assessments, service delivery plans, judicial supervision, drug testing, case management, and program evaluation to interdisciplinary education phases. The staff of this problem solving court will follow the course of a participant versus punishment and incarceration.

3) Criminal District Attorney – Vulnerable Victims Advocacy Program

Allocation: \$57,104 (Salaries and Benefits)

Positions Funded: One Violent Crimes Intake Advocate

Purpose Area: Crime Victim and Witness Program

Continuation Project since 2009 JAG

This project will continue the efforts of the current advocates for victims of violent crimes for the Bexar County Criminal District Attorney's Office. Bexar County will continue the salary and benefits of one advocate that will assist prosecutors with pertinent client information to assist in prosecution efforts. The Intake Division Advocate is available to assist victims of violent crimes and identify the families and next-of-kin in homicide cases immediately following the commission of the offense. This project will include assessing a victim's need for protection under the law, such as a protective order. Other services will include crisis intervention, advocacy, information, and referrals.

4) Bexar County Juvenile Probation Project Sentry (Gang Unit) Probation Officers

Allocation: \$88,076 (Salaries and Benefits)

Positions Funded: Two Project Sentry (Anti-Gang) Senior Juvenile Probation

Officers

Purpose Area: Corrections and Community Corrections Program

Continuation Project since FY 2010 JAG

The Juvenile Probation Office operates to provide services to children, adolescents, and their families to correct bad behavior. Juvenile Probation's project entails funding for salaries and benefits for two anti-gang senior juvenile probation officers. The anti-gang, senior probation officers provide intensive supervision and monitoring of violent juvenile offenders. This anti-gang program consist of: unscheduled visits to assigned probationers, finding guns to be logged into evidence and entered into the Bureau of Alcohol, Tobacco and Firearms (ATF) database, communicating with local law enforcement regarding gang intelligence, presenting anti-gang and anti-gun programs to local civic groups and communities, and referring gang members that express the desire to get out of gangs to community-based organization to assist this process. Additionally, the probation officers work diligently with the District Attorney's Office to coordinate prosecution.

#### 5) Bexar County Community Resources - Child Welfare Strategic Alliance Program Forensic Interviewer Services

Allocation:

\$70,147 (89.56% of Salaries and Benefits)

Position Funded: One Child Welfare Forensic Interviewer

Purpose Area:

Crime Victim and Witness Program

Continuation Program since FY 2005 JAG funding

The Justice Assistance Grant will continue efforts to protect children. The Child Welfare Strategic Alliance Task Force will fund one forensic interviewer (89.56%) to continue the efforts of law enforcement, Child Protective Services (CPS), prosecution, medical professionals and non-profit organizations to improve investigations, treatment, and management of child abuse cases in Bexar County. Various responsibilities of the forensic interviewer are to: evaluate the forensic interview of a child, review medical exams, provide input for prosecution, and review criminal and civil case dispositions. The Bexar County Department of Community Resources and the San Antonio Police Department administer this program.

#### 6). Bexar County Esperanza Court (Prostitution Prevention Program)

Drug Treatment and Enforcement Program - Prosecution and

New Program in FY 2016

The Bexar County Esperanza Court is Bexar County's felony anti-prostitution prevention court program. Substance Abuse and/or mental health treatment is an important component for the success of this specialty court. Bexar County will contract with licensed level social work entities to provide pertinent treatment for this population to become healthier members of society once again. Treatment will also provide each participant behavioral health care to include addiction and recovery education, individual and/or group therapy, an introduction to 12 step groups, relapse prevention and peer support. The local providers will use a variety of therapeutic modalities based on a cognitive-behavioral approach that accounts for individual needs relative to substances used, length of use, or cultural, age, and gender factors.

#### The City of San Antonio, San Antonio Police Department FY 2016 Justice Assistance Grant (JAG) Program and Budget Narrative

The City of San Antonio will continue its law enforcement efforts for the following programs:

1) Continue the City of San Antonio efforts of the Child Welfare Strategic Alliance Task Force by providing salaries and benefits for two detective investigator positions (Child Welfare Crimes) in the amount of \$265,924. This program will continue supporting the joint City/County project whose purpose is to conduct investigations regarding the sexual and domestic abuse cases involving children. This project collaborates with the Bexar County Sheriff's Office, the Bexar County District Attorney, Bexar County Department of Community Resources, the Texas Department of Family and Protective Services, Christus Santa Rosa Children's Hospital, and ChildSafe (a child advocacy non-profit). The City of San Antonio Police Department, Sex Crimes Unit is tasked with the investigation of more than 28 different offenses; a large portion of the Special Victim's Unit's caseload involves child victims.

#### SUBJECT:

An ordinance authorizing the application and acceptance of funds upon award, for a 2016 Justice Assistance Grant (JAG) from the U.S. Department of Justice, Bureau of Justice Assistance (BJA) and authorizing an Interlocal Agreement with Bexar County.

#### SUMMARY:

An ordinance authorizing the application and acceptance of funds upon award, for a 2016 Justice Assistance Grant (JAG) from the U.S. Department of Justice, Bureau of Justice Assistance (BJA) for a Child Welfare Strategic Alliance Program, a City/County project addressing child sexual abuse/assault not to exceed \$265,924.00; Authorizing a Cash Match of \$8,832.00 and authorizing an Interlocal Agreement with Bexar County regarding the distribution of grant funds and designating Bexar County as the grant fiscal agent; establishing a personnel complement and appropriating a budget; the grant period will be from October 1, 2015 through September 30, 2019.

#### BACKGROUND INFORMATION:

Justice Assistance Grants were first awarded in 2005. Provisions of the grant require the City and Bexar County to submit a joint application. The solicitation date for this grant was May 16, 2016. The grant funds are used to support a joint City/County project for addressing child sexual abuse/assault.

The funds for the 2016 JAG grant will be used to continue supporting the joint City/County project called Child Welfare Strategic Alliance Program. The purpose of the project is to conduct joint investigations with the Bexar County Sheriff's Office, the District Attorney's Office, the Bexar County Housing and Human Services Department, the Texas Department of Family and Protective Services, Christus Santa Rosa Children's Hospital, and ChildSafe (formally called the Alamo Children's Advocacy Center). Furthermore, the project will reduce the number of interviews required of a child victim, minimizing the negative impact of the investigation and the re-victimization of the child. The City's portion of the grant will be used to continue to fund two (2) Detective Investigator positions. These Detective Investigators will investigate sexual abuse/assault cases involving

children. Tasked with the investigation of more than 28 different offenses, a large portion of the Special Victims Unit's caseload involves children as victims.

The County will utilize the FY2016 JAG grant to continue funding grant-funded positions that are currently funded by the existing JAG programs that include problem solving courts, jail diversion, and victim advocacy. The majority of the funds will go to fund various positions (Adult & Juvenile Probation Officers, Prosecutors, Court Case Managers, etc.) in the Bexar County Drug Courts, the Bexar County District Attorney's Office, and the Juvenile and Adult Probation Offices.

The grant is for a four year period beginning October 1, 2015 and ending September 30, 2019. The total joint grant amount for the City and Bexar County is \$664,811.00. The grant funds are to be split 60% (\$398,887.00) for the County and 40% (\$265,924.00) for the City. The proposed split of funds is consistent with past agreements between the City and County.

The City's portion of the grant will be used to continue to fund two (2) Detective Investigator positions. These Detective Investigators will investigate sexual abuse/assault cases involving children. The City will have a Cash Match obligation of \$8,832.00 in order to fully fund the two positions and their operations.

The County will be responsible for submitting the grant application, the administration of the funds, including distributing the funds, monitoring the award, submitting reports including performance measures and program assessment data.

#### ISSUE:

The proposed ordinance continues the City Council's policy of seeking intergovernmental financial assistance for City crime prevention and enforcement programs addressing sexual abuse/assault of children.

#### **ALTERNATIVES:**

Other than the General Fund there is no other alternative funding source. Currently, the grant pays salaries and fringe benefits for two Detective Investigator positions. Choosing not to renew this grant will require the General Fund to absorb these positions at a time when budget austerity would make this difficult.

#### FISCAL IMPACT:

The total joint program budget for the City and Bexar County from October 1, 2015 through September 30, 2019 is \$664,811.00. The City's portion will be \$265,924.00 during the same period. A General Fund cash match of \$8,832.00 is required to make up the total cost of the two Detectives assigned to this program during the grant period. The cash match will be appropriated from the General Fund through the police operating budget for FY 2017 contingent on FY 2017 budget approval.

#### RECOMMENDATION:

Staff recommends approval of the acceptance of the grant funds and the execution of an Interlocal Agreement to continue funding two Police Detective Investigator positions to conduct child sexual abuse/assault investigations.
