AN ORDINANCE

**ACCEPTING THE OFFER FROM SILSBEE FORD TO PROVIDE THE
POLICE DEPARTMENT WITH TWO REPLACEMENT 2017 FORD
TRANSIT 350 VEHICLES FOR A TOTAL COST OF \$85,988.50, FUNDED
FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND.**

WHEREAS, an offer was submitted by Silsbee Ford, through the Texas Local Government Purchasing Cooperative (a.k.a. the “Buyboard”), to provide the City with two replacement F350 prisoner transport units for a total cost of \$85,988.50; and

WHEREAS, this purchase meets the requirements under the terms of the Texas Local Government Purchasing Cooperative agreement adopted by the City of San Antonio by Ordinance No. 97097 on January 30, 2003; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer from Silsbee Ford to provide the City with two replacement F350 prisoner transport units for a total cost of \$85,988.50 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding in the amount of \$85,588.50 for this ordinance is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5501055, as part of the Fiscal Year 2016 Budget. Funding in the amount of \$400.00 for this ordinance is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5201040, as part of the Fiscal Year 2016 Budget. Payment not to exceed the budgeted amount of \$85,988.50 is authorized to Silsbee Ford and should be encumbered with a purchase order.

SECTION 3: The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
