**A RESOLUTION RECOMMENDING DENIAL OF A STREET NAME  
CHANGE REQUEST TO CHANGE “ENRIQUE M BARRERA PKWY” TO  
“OLD HWY 90” BETWEEN US HWY 90 AND COMMERCE STREET IN  
CITY COUNCIL DISTRICT 6, SAN ANTONIO, TEXAS.**

**WHEREAS**, the Development Services Department received an application Michael Cooremans; Victor M. Aguilera; Hasmukh Patel; Homero Guerrero; Gurishkumar Patel; Bhagvan Inc.; Travel Inn; Javier Gutierrez; Frank and Cynthia De La Garza; Aurelio A. Franco; Ricardo J. Araua; Theresa and Johnny Hernandez; Diana Morino and Jahid Aragwala-AG to change the street name of “Enrique M Barrera Pkwy” to “Old Hwy 90”, between US Hwy 90 and Commerce Street; and

**WHEREAS**, according to the Application the applicants reason is to enhance the neighborhood through the association of a street name with its location, area, characteristics, and history in accordance with Chapter 6 Section 672(d)(8) of the City Code; and

**WHEREAS**, City Council approved the renaming of “Old Hwy 90” to “Enrique M Barrera Pkwy” with the memorial designation of “Historic Old Hwy 90” on September 3, 2015 through Ordinance No. 2015-09-03-0747; and

**WHEREAS**, COSA street signs have only recently been installed and TxDot is in the process of installing new signs and property owners have started to update their addresses; and

**WHEREAS**, To change the name of the street back to Old Hwy 90 at this time would cause confusion and in some cases a financial hardship for the citizens who have recently changed their address; and

**WHEREAS**, Chapter 6 of the City Code of San Antonio, Texas, requires street name change requests to be considered by the Planning Commission of the City of San Antonio and its recommendation forwarded to the City Council; and

**WHEREAS**, the City of San Antonio Development Services Department in accordance with Chapter 6 of the City Code of San Antonio, Texas, notified all of the two hundred thirty-two (232) abutting property owners of real property along the segment of the street proposed for the name change; and

**WHEREAS**, the Planning Commission of the City of San Antonio held a public hearing on August 10, 2016, where they reviewed evidence and received public testimony regarding the proposed street name change;

**NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO THAT:**

**SECTION 1:** The Planning Commission of the City of San Antonio recommends **DENIAL** of the proposed street name change from “Enrique M Barrera Pkwy” to “Old Hwy 90”, between US Hwy 90 and Commerce Street in City Council District 6 (**Exhibit “A”**).

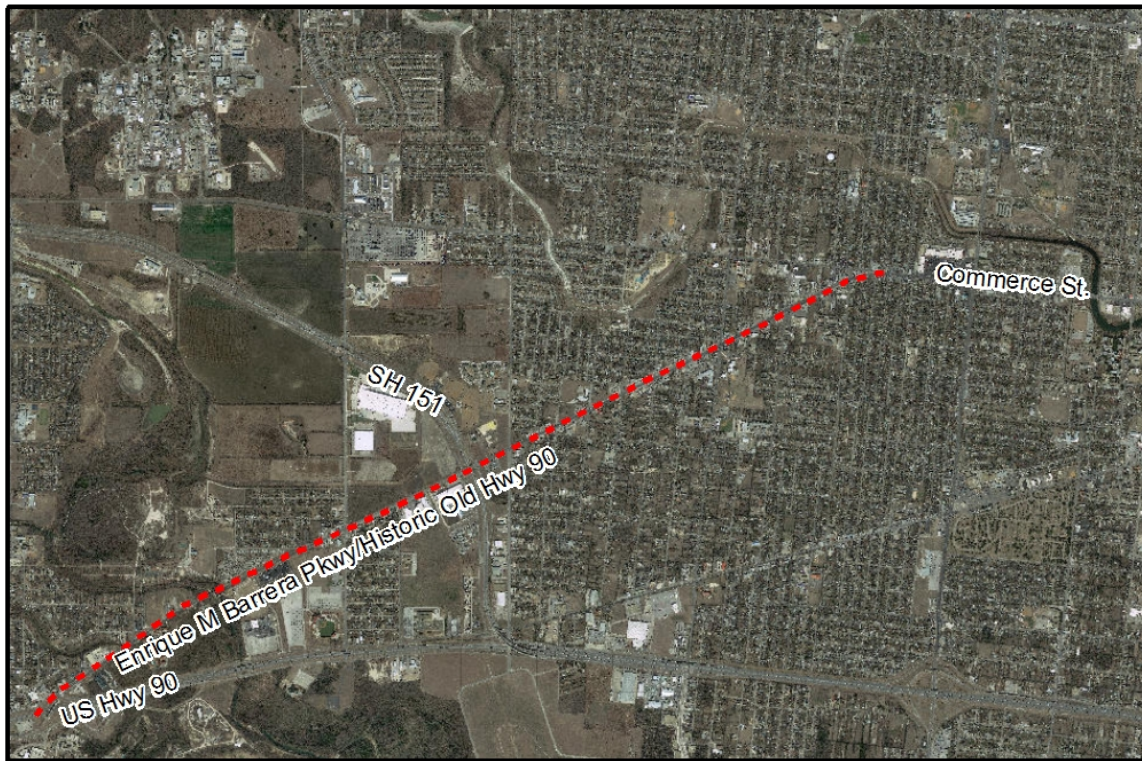
