## AN ORDINANCE 2016-08-18-0613

AWARDING A CITY COUNCIL PROJECT FUND GRANT ALLOCATION IN AN AMOUNT NOT TO EXCEED \$16,000.00 TO SUPPORT THE JOCI AWARDS PERFORMING ARTS SCHOLARSHIP.

WHEREAS, the Joci Awards Performing Arts Scholarship Competition works to identify students' artistic strength, encourage college enrollment, and increase performing arts awareness and attendance and has resulted in annual scholarships of \$100,000.00 to 25 students competing in acting, singing, and dancing; and

WHEREAS, this Ordinance awards a grant allocation to the Las Casas Foundation through the City Council Project Funds Program from four City Council Districts, in an amount not to exceed \$16,000.00 in support of this Competition; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** A grant allocation to the Joci Awards Performing Arts Scholarship in an amount not to exceed \$16,000.00, and any additional funding within this fiscal year, is hereby approved. Funding for this allocation is made possible through CCPF contributions made by the following City Council Districts:

Council District 3	\$1,000.00
Council District 8	\$5,000.00
Council District 9	\$5,000.00
Council District 10	\$5,000.00

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
