AN ORDINANCE 2016-08-18-0614

AUTHORIZING THE ACCEPTANCE AND APPROPRIATION OF A GRANT IN THE AMOUNT UP TO \$391,863.00 FROM SOUTHWEST TEXAS REGIONAL ADVISORY COUNCIL FOR TRAUMA FOR USE BY THE MOBILE INTEGRATED HEALTHCARE UNIT OF THE EMERGENCY MEDICAL SERVICES DIVISION OF THE SAN ANTONIO FIRE DEPARTMENT TO WORK WITH PEDIATRIC ASTHMA PATIENTS.

WHEREAS, the Southwest Texas Regional Advisory Council for Trauma (STRAC) has awarded grant funds in the amount of \$391,863.00 to the San Antonio Fire Department (SAFD) to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division for its work with pediatric asthma patients in an effort to reduce admissions to emergency rooms throughout the City; and

WHEREAS, no cash or in-kind matching contributions are required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to accept grant funds in the amount of \$391,863.00 from the STRAC that will be used by the MIH Unit of the SAFD EMS Division for its work with pediatric asthma patients in an effort to reduce admissions to emergency rooms throughout the City. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said acceptance.

SECTION 2. Upon approval, a new fund and internal order will be created for use in the accounting for the fiscal transactions in the acceptance of this grant. A sum not to exceed \$391,863.00 will be appropriated in said fund.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
