The City Council of San Antonio convened in a Regular Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

1. The Invocation was delivered by Pastor Alex Lara, Elevate Ministries, guest of Councilmember Rey Saldaña, District 4.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the Regular City Council Meetings of June 1 - 2, 2016 and the Budget Goal Setting Session of June 8, 2016.

Councilmember Gallagher moved to approve the Minutes for the Regular City Council Meetings of June 1-2, 2016 and the Budget Goal Setting Session of June 8, 2016. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Sheryl Sculley reported that her recommendation was to confirm the appointment of Andrew Segovia as the City Attorney of the City of San Antonio. She stated that he was one of 31 applicants that applied for the position and highlighted his background and experience. She added that Mr. Segovia was selected after interviewing with three panels and was excited to return to his hometown of San Antonio.

Mr. Andrew Segovia addressed the City Council and stated that he was honored and humbled to serve as the City Attorney for the City of San Antonio. He commended the selection process and recognized his family that supported his decision to come home to San Antonio. He thanked Acting City Manager Martha Sepeda for her support in the transition and stated that he would continue to rely on her expertise and insight.

Mayor Taylor called the citizens registered to speak.

Councilmember Medina noted that said project was a District 7 Project and not a District 6 Project. Razi Hosseini presented a map of the location and stated that the project would help improve the entrance to St. Mary's University. He noted that the improvements would include widening the street, installing a left turn lane, traffic signals, and curb and sidewalk construction. He added that the project was scheduled for completion in March 2017. Councilmember Medina stated that they had waited a long time for the project to be implemented and looked forward to its completion.

Mayor Taylor called Nazirite Ruben Flores Perez to speak.

Mr. Nazirite Ruben Flores Perez expressed his support for the acquisition and spoke of the importance of protecting the Aquifer. He noted concerns with fluoride in the water supply.

Councilmember Nirenberg highlighted the acquisition and asked for additional information. Xavier Urrutia stated that there would be a cumulative of 142,000 acres protected and that this property was noteworthy because it was in the Sabinal River Watershed. Councilmember Nirenberg thanked the voters and stated that he was pleased to continue to preserve the water supply.

Councilmember Nirenberg moved to adopt the Ordinance for Item 13. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran highlighted the program and asked of the entities that would work on the program. Chief McManus replied that they would work with the Bexar County Sheriff's Office, District Attorney's Office, and Housing and Human Services Department, as well as the Texas Department of Family and Protective Services, Christus Santa Rosa Hospital, and ChildSafe. Councilmember Viagran asked of the focus of the program. Chief McManus stated that the program had been in place since 2005 and funded two Detectives from the San Antonio Police Department assigned to ChildSafe. He noted that they were able to focus on Child Abuse, Sexual Abuse, and Assault Cases that came into ChildSafe. Councilmember Viagran expressed her support and stated that it was important to highlight this for the community.

Councilmember Viagran moved to adopt the Ordinance for Item 20. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran highlighted the program and stated that it was important to highlight because of the tie between drug trafficking and violence. Chief McManus stated that they would be working with the High Intensity Drug Trafficking Areas (HIDTA) Task Force, Drug Enforcement Agency, Department of Public Safety, and Homeland Security Investigations. He noted that they investigate drug trafficking in the San Antonio Metropolitan Area and ensure that each entity does not interfere with each other's investigations. Councilmember Viagran stated that she was pleased with the collaboration among the various entities to address violence and drug trafficking.

Councilmember Viagran moved to adopt the Ordinance for Item 21. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

Councilmember Krier asked for an overview of the project. Mr. Jones replied that the City Council had authorized a 20-year Lease and Concession Agreement with Northwest Petroleum, LP on May 12, 2016 subject to City Council approving the Design Concept. He noted that Aviation Staff and Northwest Petroleum have worked together since the meeting to increase landscaping, add foliage, add crepe myrtles to mirror current

landscaping along Airport Boulevard, and protect the nighttime lighting of the Monument Sign. He provided photos of the area from various angles and stated that staff recommended approval. Councilmember Krier thanked Councilmember Treviño for highlighting the issue when it was initially presented to the City Council. Councilmember Gallagher expressed his support for the Gas Station and stated that he was pleased with the concept of tying it into the Cell Phone Waiting Lot.

Councilmember Medina also expressed his support and stated that he was pleased to improve the customer experience. Councilmember Treviño stated that the Airport was very important to the city and was pleased with the minor improvements made to the design that will have a major impact.

Councilmember Treviño moved to adopt the Ordinance for Item 23. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

- 28.** A Resolution of No Objection for RELEE Preservation Associates, L.P.'s application to the Texas Department of Housing and Community Affairs for 4% Housing Tax Credits programs for the acquisition, rehabilitation and refinancing of a 72 unit multi-family rental housing development, located at 111 W. Travis Street in Council District 1. [Peter Zanoni, Deputy City Manager; Bridgett White, Interim Director, Planning and Community Development]

Bridgett White stated that the Resolution of No Objection for Non-Competitive 4% Housing Tax Credits was being requested from the Texas Department of Housing and Community Affairs (TDHCA) for the Robert E. Lee Apartments located at 111 W. Travis Street. She noted that the owner was submitting an application to the State for Housing Tax Credits. She indicated that there was no City Financing associated with the project and that it had been presented to the Housing Council Committee on June 22, 2016. She added that the 4% Credit Equity was valued at \$2.5 Million and that all 72 units would be affordable.

Councilmember Treviño stated that he was in support of the proposal for 72 units located in the heart of Downtown where this type of housing was needed.

Councilmember Viagran asked what would happen to the current residents. Ms. White replied that the residents in the building would not be displaced. Councilmember Viagran

asked if the item would have to be approved by the Historic Design and Review Commission (HDRC) due to the name change. Ms. White stated that the owner was open to changing the name and that the process would occur in partnership with the Office of Historic Preservation. She added that certain improvements would have to be made as part of the Tax Credit Process. Councilmember Viagran expressed concern for the residents and the potential rent increase. Lori Houston stated that they had been working closely with the Planning Department and Developer and they were committed to not displacing any of the residents. She noted that they were also committed to activating the first floor of the building and upgrading the units.

Councilmember Saldaña asked if the rental rates would remain the same. Mrs. Houston stated that they would be required to meet the affordability rate in order for them to receive the Affordable Tax Credit. She added that the State was required to monitor compliance with the application they submit. Councilmember Saldaña asked of an extra layer of assurance. Mrs. Houston replied that they worked with the Developer to ensure that the residents would not be displaced and that they would perform the necessary improvements. She noted that they also requested a Relocation Plan for residents that would have to move out of their unit while it was been upgraded.

Councilmember Warrick asked if the rent could be increased. Ms. White stated that if it was an affordable unit, the rates have to be affordable for those at 60% or below the Area Median Income (AMI). Mrs. Houston added that they would monitor the project to ensure that no residents were forced to relocate. Councilmember Warrick asked of the process to rename the building. Mrs. Houston stated that they would work with the Office of Historic Preservation and the Conservation Society to ensure that the Historic Character of the building is maintained. She noted that it did not have to go through a renaming process as it was not owned by the City of San Antonio.

Mayor Taylor stated that although it was important to protect the availability of affordable housing stock in the Inner City; the facility was in great need of improvements that may not be made if the Resolution of No Objection is not approved. She noted that because many of the residents were below 60% of AMI, they may not be able to continue to reside there. She expressed concern with allowing a very visible building in the middle of Downtown to continue to deteriorate. She noted that low-income housing was a challenge for the community and hoped to continue discussion at the Housing Summit that would be held in September.

Councilmember Viagran asked why the item was being presented to the City Council. Mrs. Houston replied that the State of Texas requires the local jurisdiction to approve a Resolution supporting an application for a 4% Tax Credit. She stated that the Resolution

would allow the City of San Antonio to continue working with the Developer as an Affordable Housing Partner and ensure that the units remain affordable. Councilmember Viagran expressed concern with Disabled and Senior Citizens that may not be able to continue to live at the facility.

Councilmember Medina asked of the difference between a Resolution of No Objection and a Resolution of Support. Ms. White replied that the State used a Resolution of No Objection which meant that the city was not opposed to what they are proposing. Councilmember Lopez confirmed that a Resolution of No Objection was all that was required for a 4% Non-Competitive Tax Credit.

Councilmember Nirenberg stated that he drove by this building almost every day and it was a deteriorating facility with a distressed landlord. He expressed support and noted that staff should ensure that they are meeting their commitments.

Councilmember Saldaña asked why the Developer would not elect to turn the property over to the private market. Mrs. Houston stated that they had owned the building for over 20 years and wanted to continue operating as an Affordable Housing Project. She noted that they could sell the building but had opted not to move forward with that option. Councilmember Warrick added that 60% of the AMI was \$26,100 for one person and \$37,260 for a family of four and that information made it an easier decision to move forward with this type of project.

Mayor Taylor noted that they need to continue these conversations in the future to try to identify solutions and options.

Councilmember Treviño moved to approve the Resolution for Item 28. Councilmember Krier seconded the motion. The motion prevailed by the following vote:

A. Mrs. Sculley announced that all three of the major ratings agencies have reaffirmed the City of San Antonio's "AAA" Bond Rating for the seventh straight year. She stated that San Antonio was the only city of over 1 million residents with a "AAA" Rating from the ratings agencies. She noted that the "AAA" rating allows the city to access the lowest possible interest rates in the market, which puts more tax dollars toward projects like streets and sidewalks, rather than toward paying interest costs. She reported that on Tuesday, the City sold \$331 Million in General Obligation Bonds, Certificates of Obligation, and Tax Notes. She noted that the sale included the refinancing of old debt; resulting in \$26 Million net present value savings. She added that they also completed the last issuance of \$54 Million in debt for projects in the 2012 Bond Program.

B. Mrs. Sculley provided a status on the 2016 Infrastructure Management Program (IMP). She stated that the IMP was a rolling five-year program of Infrastructure Projects targeting maintenance and improvements for streets, sidewalks, and drainage. She noted that the IMP includes signal and intersection improvements, bicycle facilities, and pedestrian safety improvements. She reported that this year's IMP prioritizes over 1,200 Infrastructure Projects totaling \$88 Million funded through General Fund, Advanced Transportation District (ATD) Funds, and Storm Water Utility Fee. She stated that by the end of FY 2016; the city will have improved nearly 280 miles of streets and constructed over 30 miles of sidewalks. In addition, she noted that the 2012 Bond Program was on time and within budget. She added that of the 140 Bond Projects; 77 were complete, 51 under construction, and 12 under design.

Mrs. Sculley reported that the Convention Center Expansion Team and Private Sector Partners were recently recognized with a National Award of Merit from the Design-Build Institute of America. She stated that the prestigious award recognizes Design-Build Projects and Teams that demonstrate Best Practices and Innovative Ways of incorporating Design, Modern Technology, and Flexibility.

C. Mrs. Sculley reported that on July 22nd she appointed a Fiber Deployment Team managed by the TCI Department and led by Assistant Capital Programs Manager Marcus Hammer to ensure all on-going Fiber Network Deployment Initiatives are managed in accordance with City Standards. She stated that they would ensure that installation was done with minimal disruptions to streets, parks, utilities, and other core city functions. She noted that the City's Fiber Deployment Team would be actively engaged in all aspects of deployment to include construction oversight and community and stakeholder communications. She reported that Google Fiber, AT&T and the Zayo Group have a total of 110 crews working in the Right-of-Way across the city with the number to increase to 200 crews over the next few years. She mentioned that the Fiber Deployment Team has

developed a Communication Plan to ensure adequate notifications prior to the start of construction. She added that they have placed a temporary hold on future Google Prefabricated Shelter Construction until the Communication Plan is fully implemented. She stated that they have an assigned hotline to respond to all Fiber Deployment-Related Inquiries which could be reached at 207-5741.

Councilmember Warrick congratulated staff on the AAA Bond Rating but stated that he would like to challenge staff to do more with less during the upcoming budget process. Councilmember Krier spoke of issues with the installation of fiber lines in his district and asked that staff work more closely with the Fiber Companies to ensure minimum disruptions to the neighborhoods. Councilmember Gallagher stated that fiber installation had also been an issue in District 10 and spoke of the importance of ensuring that everybody is aware of the process. Councilmember Medina stated that he was pleased with the AAA Bond Rating and the Fiber Deployment Team that was created. He acknowledged two interns that worked in District 7; Celeste Dominguez and Julia Medellin, and thanked them for their great work. Mayor Taylor congratulated staff on the AAA Bond Rating and stated that she was pleased with the implementation of a Fiber Deployment Team. She stated that eight interns had worked in her office over the summer and recognized two that were present: Marissa Elder and Katherine Howell. She thanked all of the interns for their great work.

Mayor Taylor recessed the meeting at 11:12 am and announced that the meeting would resume at 2:00 pm for Zoning.

He stated that he was opposed to the Bar requested in Item Z-3 and noted that the King William Neighborhood Association was in opposition.

Rita Martinez addressed the Council against the Plan Amendment and Rezoning. She stated that she was a Licensed Clinical Social Worker and spoke of the negative effects of crime and stress. She added that there were already many bars in the area.

Councilmember Treviño thanked everyone that spoke today and moved to deny Items P-1 and Z-1. Councilmember Warrick seconded the motion.

Councilmember Medina commended Councilmember Treviño for his work on the issue and recognized the hard work that had occurred on the Northwest Community Plan.

For Item Z-10, she stated that staff recommended denial while the Zoning Commission recommended approval. She reported that of 17 notices mailed; 3 were returned in favor and none in opposition.

Councilmember Viagran stated that the original application was for a C-2 Designation but they had amended it to C-1. She submitted 19 signatures in support of the rezoning.

Councilmember Viagran moved to approve Items P-5 and Z-10 with a C-1 Designation. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Catherine Hernandez presented Item Z-18 and stated that staff and the Zoning Commission recommended approval. She reported that of 32 notices mailed; 2 were returned in favor and 11 received in opposition. She stated that 14 notices were received in opposition from individuals outside of 200 feet while 2 notices were received in support from individuals outside of 200 feet. She added that due to opposition exceeding 20%; the case would require 9 votes for approval.

Mayor Taylor called the citizens registered to speak.

Bill Fitzgibbons stated that he owned four properties on Lone Star Boulevard and was supportive of the request. He noted that it would be an asset to the community and welcomed this type of development in the Lone Star Area.

Ann Fitzgibbons also expressed her support and stated that the Microbrewery would fit well

with the Lone Star Community Plan.

Ramona Rivera showed a video in opposition to the request. She expressed concern with the lack of emergency access and with the location of the bar within a neighborhood.

Nathaniel Rivera stated that he was an Eighth Grade Student at Basis Central and opposed to the request. He expressed concern with parking, traffic, and safety for children in the neighborhood.

Boyan Kalusevic stated that he was the Owner of a Distilling and Brewing Company in the area and was in support of the rezoning. He spoke of the work they have accomplished to clean up the neighborhood and noted that this would be a good contribution for the community.

Jason Meredith addressed the City Council in support of the rezoning and stated that brewing craft beer was an Art. He noted that there would be no live music onsite and a limited amount of tables.

Jennifer Smith addressed the City Council in support of the rezoning. She stated that she was excited with what they would bring to the neighborhood and their plans to promote bikers and walkers.

Vera Deckard stated that she was the Applicant and that she would like to contribute her talent for brewing craft beer to the community. She noted that they were not considered a bar but a Craft Brewery. She added that they were downzoning to a C-2 Designation and were working on a parking solution.

Susan Powers, President of the Lone Star Neighborhood Association addressed the City Council in support of the request. She stated that she was pleased with the downzoning and added that she had not received any phone calls from the community opposing the request.

Dolores Menchaca Martinez stated that they had been working with Ms. Deckard on her request and were in support. She noted that this would provide positive growth and development in the area and that the location would serve as a good meeting place for the community.

Mike Farringer stated that he was the Operations Director for San Antonio Brewing Company and supportive of the request. He noted that they would serve other beverages besides craft beer and would help support the local community.

Michael Martinez stated that he had lived in the area all of his life and was very supportive of the request. He noted that this was a good opportunity for the neighborhood and did not understand the opposition.

Enrique Cortez stated that he was opposed to the request due to the alcohol consumption and parking issues.

Juan Gonzales stated that he was also opposed to the request due to the parking, traffic, and crime it would bring to the area. He expressed concern with the alcohol consumption and noted that there were other bars already in the area.

A. Clark stated that he was an Investor in the Brewing Company and supportive of the request. He stated that craft brewing was about low volume and high quality and that the establishment would bring positive development to the area.

Mrs. Vacek announced that written testimony was received in support of Item Z-18 from Roger Zapata, Lone Star Neighborhood Association.

Councilmember Gonzales thanked everyone that come to speak and asked of the issues of parking and noise. Ms. Vera Deckard stated that there was some parking in front and on the side of the building and would work on other options. She added that they were looking at a potential Rewards Program for those that walk or ride their bikes to the brewery. With regard to noise, she stated that their hours of operation would be from 4:00 to 11:00 pm with limited outside seating. She noted that there would not be any live music.

Councilmember Gonzales moved to approve Item Z-18. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:
