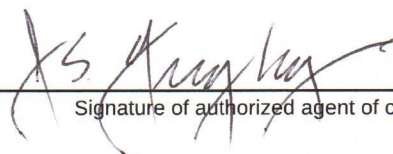

FuelRod Program Proposal

San Antonio International Airport (SAT)

Objective:

Install and maintain multiple FuelRod Kiosks in and around the San Antonio International Airport to provide travelers with a convenient portable charging alternative for their smartphones and tablets.

Program Description:

FuelRod will mutually agree to install and maintain a specific number of kiosks in publicly accessible locations to dispense FuelRod kits and exchange or “Swap” individual FuelRods. Each FuelRod kit will include a fully charged “ready to go” FuelRod, a USB to Micro-USB cable, and adaptors for connection to Apple products.

Consumers may purchase a FuelRod Kit for \$20.00 from the FuelRod Kiosk. The FuelRod will charge a standard iPhone or Android phone one time (provides about 30% charge for an iPad). Once used or discharged, the FuelRod can be re-charged using a USB connection, or may be exchanged or “Swapped” at any FuelRod Kiosk for a fresh – fully charged FuelRod. Currently the cost of Swapping a FuelRod is \$0.

Business terms:

10% Share of gross revenues
Minimum term 2 years (Requested)

Anticipated Costs and Responsibilities:

Airport – No out of pocket expense. Provide publicly accessible locations for Kiosk installation. Allow FuelRod personnel or contracted service organization access to the kiosks for servicing and replenishment (we expect to contract with a local service provider who is already servicing businesses in the Airport)

FuelRod – All capital equipment, stock, installation and service costs. Including the cost of running a new circuits where needed to provide an electrical outlet to a chosen location.
