**AN ORDINANCE**

**AMENDING THE FISCAL YEAR 2016-17 CONVENTION &  
SPORTS FACILITIES CAPITAL BUDGET TO INCLUDE A NEW  
PROJECT FOR ALAMODOME IMPROVEMENTS IN  
PREPARATION FOR THE ARMY VS. NOTRE DAME  
FOOTBALL GAME, AND APPROPRIATING FUNDS IN THE  
AMOUNT OF \$334,089.00 FROM THE CSF STATE  
REIMBURSEMENT FUND.**

**WHEREAS**, the University of Notre Dame vs. Army NCAA football game will take place on November 12, 2016 at the Alamodome and in order to prepare for the event, the Convention and Sports Facilities Department needs to make improvements at the facility which are vital to the success of the event, including the purchase of 67 metal detectors, press box audio improvements, the purchase of various audio and video equipment, and signage/wayfinding improvements (“Improvements”); and

**WHEREAS**, the cost of the Improvements will be approximately \$334,089.00 and staff proposes that it come from funds previously reimbursed by the State Event Trust Fund for prior events, requiring amendment of the Fiscal Year 2016-17 Convention and Sports Facilities Capital Budget; and

**WHEREAS**, the City intends to seek reimbursement from the State Events Trust Fund for the expenses associated with the Improvements; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Fiscal Year 2016-17 Convention and Sports Facilities Capital Budget is amended to include Alamodome improvements in preparation for the Notre Dame vs. Army football game and funds in the amount of \$334,089.00 from the CSF State Reimbursement Fund are appropriated for the Improvements.
