This Agreement is entered into by and between the City of San Antonio, Texas, a home-rule municipal corporation (City), by and through its Director of Finance or said Director's designee, and Konica Minolta Business Solutions U.S.A., Inc. City acknowledges that City is awarding a contract for the purchase of the equipment offered by Konica Minolta, and is not awarding a contract for the lease of equipment.
