AN ORDINANCE 2016 - 09 - 01 - 0660

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED KOPPLOW DEVELOPMENT, INC. V. CITY OF SAN ANTONIO, CAUSE NO. 2004-CI-08167-A PENDING IN THE 285th JUDICIAL DISTRICT COURT, BEXAR COUNTY, TEXAS FOR PAYMENT IN THE AMOUNT OF \$850,000.00 PLUS INTEREST AND COURT COSTS.

* * * * *

WHEREAS, after the record floods of 1998 and 2002, the City of San Antonio (City) conducted a study to address flooding issues along Leon Creek. Based upon the hydrology study, the City constructed an approximate 200 acre regional storm water facility on Leon Creek located near the intersection of Culebra Road and Loop 410, downstream of property owned by Kopplow Development, Inc. (Plaintiff). Also during this timeframe, the City revised its regulatory 100-year floodplain to include this hydrological data. That revision resulted in significant changes to the City's regulatory floodplain and the FEMA floodplain.

WHEREAS, Plaintiff filed a lawsuit against the City alleging statutory condemnation, and physical and regulatory taking of its property; and

WHEREAS, it is in the City's best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the City and Plaintiff have mediated this matter and have reached an agreement to settle this lawsuit against the City for \$850,000.00 plus interest and cost costs subject to City Council approval; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Payment of \$850,000 plus interest and court costs for an approximate total amount of \$1,369,840.52 is authorized in accordance with an approved settlement agreement.

SECTION 2. The settlement amount is authorized to be paid from Fund 75001000, General Ledger 5402530 and Cost Center 1009020001, and is authorized to be made payable to Kopplow Development, L.P. f/k/a Kopplow Development, Inc. as settlement of Cause Number 2004-CI-08167-A, styled: Kopplow Development, Inc. v. City of San Antonio.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
