AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$5,001,021.15: (A) BIKE WORLD FOR BICYCLE REPAIR PARTS AND ACCESSORIES FOR BICYCLE PATROL OFFICERS, (B) VULCAN CONSTRUCTION MATERIALS, LLC, FOR ASPHALT AND POTHOLE PAVING MATERIALS, AND (C) INNOVATIVE INTERFACES, INC., FOR MILLENNIUM SOFTWARE MAINTENANCE AND SUPPORT INCLUDING TELNET ACCESS.

WHEREAS, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

WHEREAS, these bids are from the following companies to furnish the City with: (A) Bike World for bicycle repair parts and accessories for bicycle patrol officers, (B) Vulcan Construction Materials, LLC, for asphalt and pothole paving materials, and (C) Innovative Interfaces, Inc., for Millennium software maintenance and support including telnet access; and

WHEREAS, the bid submitted by Ride Away Bicycles failed to meet the City's specifications and/or requirements for bicycle repair parts and accessories for bicycle patrol officers; and

WHEREAS, according to section 252.022(a)(7) of the Texas Local Government Code competitive bidding is not required for a procurement of items that are available from only one source; and

WHEREAS, this ordinance approves one low qualifying bid contract, one low bid contract, and one contract procured on the basis of sole source; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids from the following companies to furnish the City with: (A) Bike World for bicycle repair parts and accessories for bicycle patrol officers, (B) Vulcan Construction Materials, LLC, for asphalt and pothole paving materials, and (C) Innovative Interfaces, Inc., for Millennium software maintenance and support including telnet access. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bid submitted by Ride Away Bicycles for bicycle repair parts and accessories for bicycle patrol officers failed to meet the City's specifications and/or requirements.

SECTION 3. Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2016 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
