## AN ORDINANCE

AUTHORIZING AN INTERLOCAL AGREEMENT WITH THE CENTER FOR HEALTH CARE SERVICES IN THE AMOUNT OF \$899,965.00, WITH A REQUIRED IN-KIND MATCH OF \$299,988.00, FOR THE PERIOD OF SEPTEMBER 30, 2016 THROUGH SEPTEMBER 29, 2017 FOR THE BEXAR CARES PROGRAM; AND AMENDMENTS BASED ON ADDITIONAL GRANT AWARDS OR PROGRAM IMPROVEMENTS.

WHEREAS, in March 2014, the U.S. Department of Health and Human Services Substance Abuse and Mental Health Services Administration (SAMHSA) released a grant opportunity related to the Comprehensive Community Mental Health Services for Children with Serious Emotional Disturbances; and

**WHEREAS**, the City accepted a grant pursuant to Ordinance No. 2015-04-16-131 to expand the existing system of care, Bexar CARES ("Program"), with sub-recipient Center for Health Care Services ("CHCS") to further improve behavioral health outcomes for children and youth with serious emotional disturbances for Years 1 & 2 of a four-year Program; and

**WHEREAS**, on February 11, 2016, Ordinance No. 2016-02-11-0081 authorized the application for and acceptance of funds for Year 3 of the Program, as well as the acceptance of additional awards during the term so long as matching funds are available in City's budget; and

WHEREAS, CHCS serves as a direct service provider and referral agent for school-aged children, directing them to various community collaborators to provide holistic support services; and

**WHEREAS**, the City, as program grantee, is responsible for implementation of the Program and data collection, reporting, and monitoring for continuous quality improvement; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is authorized to execute an Interlocal Agreement with the Center for Health Care Services in the amount of \$899,965.00, with a required in-kind match of \$299,988.00, for the period of September 30, 2016 through September 29 for

the Bexar CARES Program. A copy of the Interlocal Agreement, in substantially final form, is attached hereto and incorporated herein for all purposes as **Attachment I**.

**SECTION 2**. The City Manager or her designee, or the Director of DHS or her designee, is further authorized to negotiate and execute contract amendments based on additional grant awards or program improvements.

**SECTION 3**. A proposed budget, attached and incorporated herein for all purposes as **Attachment II**, is approved.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
